address.

Pre-entries are **\$20.00** for the first run and **\$17.00** for 2<sup>nd</sup> run, \$13.00 for  
additional run for the **same dog in the same trial**. Discount example. AG1 and AG2  
same dog same trial. If you are entering AG1 each trial would be \$40.00. If you are  
entering AG1 and AG2 each trial, would be \$20 plus \$17 each trial.

**Following closing date, entries are \$25.00 each class.**

Weekend **GRACH Special: \$50.00-All 3 Levels** for the **same**  
**dog/same trial - Pre-Entry Only.**

**Junior Handler entries are \$12.00 Day of Show JR \$15.00**
