### **AFTERMATH: LESSONS IN SELF-DEFENSE** *What To Expect When the Shooting Stops*



Now that you have made the decision to arm yourself for self-defense, you need to consider whether you have given adequate thought to the consequences of your involvement in a deadly force encounter? What are the chances that something like that is actually going to happen to you?

Conservative estimates place the number of self-defense incidents nationwide at over 100,000 times each year, although some commentators place the number higher than that. From a practical perspective, your odds are 50-50. It is either going to happen ... or it is not. If it does, after you have survived the fight, then what do you do? What do you say, to whom, and when? How do you deal with neighbors, friends, your own family, the media, and the police? How do you protect yourself legally in the ongoing battle to protect your life and liberty?

You may have survived the first attack. The information in this day will help you survive what comes later: The criminal court proceeding. A civil court case.

This is the day that will prepare you for what happens a few seconds after the guns quit firing and what to expect in the Aftermath of a Self-Defense Gun Fight.
