- ❖ Dorothy Spoerl, town resident, joined our meeting to let the Board know of the interest in becoming a Town Auditor. We have one position open for a 2-year Auditor that had not been taken during Town meeting. Christy also mentioned that there was another interested party for the job, who spoke to her about it after Town meeting was done. With this information the Board decided that they would like a letter about why they would be a good fit for the job and a resume on their experience. The Board would like this information for the next Board meeting in a few weeks. Dorothy agreed to do this, and Christy will get in touch with the other interested party to have them do the same.
- ❖ Jason Powers joined our meeting to get an update on when the Board would be removing the bus from the town right of way on his road. The Board assured him that they would be speaking with the owner of the bus on Monday and that the bus would be moved by the following weekend. Jason also wanted an update on when they would be fixing the road to be put back to its original center, the Board assured him that this would be done shortly after the removal of the bus.

- ❖ Christy presented the Board with the LEMP (Local Emergency Management Plan) adoption renewal for them to review. After reviewing it, the Board approved the LEMP, and Alden, the board Chair signed the adoption renewal form. Christy will be sending this back to NVDA for the final approval.
- ❖ Calvin updated the Board on the roadside tree cutting that was done on Cheney rd. and Lamphere rd. He also let the Board know that he would begin filling the potholes with cold patch this coming Wednesday the 23rd of June.
