The Department of Veterans Affairs' (VA) regulations to establish presumptions for the service connection of eight diseases associated with exposure to contaminants in the water supply at Camp Lejeune, North Carolina, are effective as of today, March 14, 2017.

"Establishing these presumptions is a demonstration of our commitment to care for those who have served our nation and have been exposed to harm as a result of that service," said Secretary of Veterans Affairs, <u>Dr. David J.</u> <u>Shulkin</u>. "The Camp Lejeune presumptions will make it easier for those Veterans to receive the care and benefits they earned."

The presumption of service connection applies to active-duty, reserve and National Guard members who served at Camp Lejeune for a minimum of 30 days (cumulative) between Aug. 1, 1953, and Dec. 31, 1987, and are diagnosed with any of the following conditions:

• Adult leukemia

• Aplastic anemia and other myelodysplastic syndromes

- Bladder cancer
- Kidney cancer
- Liver cancer
- Multiple myeloma
- Non-Hodgkin's lymphoma
- Parkinson's disease

The area included in this presumption is all of Camp Lejeune and Marine Corps Air Station New River, including satellite camps and housing areas.

This presumption complements the health care already provided for 15 illnesses or conditions as part of

the <u>Honoring America's Veterans and Caring for Camp</u> <u>Lejeune Families Act of 2012</u>. The Camp Lejeune Act requires VA to provide health care to Veterans who served at Camp Lejeune, and to reimburse family members or pay providers for medical expenses for those who resided there for not fewer than 30 days between Aug. 1, 1953, and Dec. 31, 1987.

VA Mental Health Care for Vets with OTH Discharges:

During a hearing before the House Committee on Veterans' Affairs on Tuesday, Secretary of Veterans Affairs David J. Shulkin announced that VA will no longer turn away veterans seeking urgent mental health care simply because they received other-than-honorable discharges. VA plans to implement the new rule later this year.

Veterans in crisis should call the Veterans Crisis Line at 800-273-8255 (press 1), or text 838255.

<u>The House Committee on Veterans' Affairs held a</u> <u>markup to consider five bills.</u>

The committee deliberated and advanced bills to:

- 1. Give the Secretary of Veterans Affairs increased authority to hold VA employees accountable for wrongdoing and poor performance.
- 2. To protect veterans' second amendment rights and destigmatize mental health care by ensuring veterans who seek VA mental health care and require the assistance of others to manage finances are not reported to the firearms no-sell list without proper due process.
- 3. A bill to remove the secondary payer requirements under the Choice Program, so veterans no longer receive bills from Choice providers simply because they are covered by private health insurance.
- 4. No. 3 would also prolong the program by authorizing VA to use funds that are due to expire in August 2017.
- 5. A bill that would provide full Post-9/11 GI Bill benefits to veterans who have earned the Purple Heart, but were unable to complete 36 months of active duty.

All five bills await consideration by the full House, which is scheduled to consider the accountability bill and other veterans' bills next week.

US Parks Service Senior Pass

Seniors (meaning those over 62) can obtain a National Parks and Federal Recreational Lands Pass for **\$10.00**. A pass covers entrance, standard amenity fees and day use fees for a driver and all passengers in a personal vehicle at per vehicle fee areas (or up to four adults at sites that charge per person). Children age 15 or under are admitted free.

The fee for the pass is scheduled to go up to \$ 70.00 at the end of the year so this is the time to get it.

The pass is good for the lifetime of the holder. If you order it online it ends up costing \$ 20.00, but you can purchase it in person for the \$ 10.00. I bought mine at Wallkill and you have to pay by check, they don't take cash.

<u>New tax breaks in New Jersey for veterans and</u> seniors

A series of changes to the New Jersey tax code took effect on January 1 designed to help offset the rise in the gas tax. Starting with this 2017 tax year these two changes help most veterans and seniors (of which we are both):

Expanding tax deduction for retirees

A married couple filing their taxes jointly can currently exclude their first \$20,000 in retirement income from state income taxes. But beginning in 2017 and phased in over four years, that amount will ultimately increase to \$100,000 for joint filers, \$75,000 for individuals and \$50,000 for those married who are filing separately.

Tax deduction for veterans

The tax deal introduced a \$3,000 tax deduction for veterans. The law defines veterans as those who are "honorable discharged or released under honorable circumstances from active duty in the Armed Forces of the United states, a reserve component thereof, or the National Guard of New Jersey in a federal active duty status."

Donations of used prosthetics / artificial limbs

Soldier Missing From Korean War Accounted For (Mitchell) March 15, 2017 — Army Pfc. Robert E. Mitchell, missing from the Korean War, has now been identified. On Sept. 6, 1950, Mitchell was assigned to Company F, 2nd Battalion, 38th Infantry Regiment, 2nd Infantry Division, <u>MORE</u>

VA's Rule Establishes a Presumption of Service Connection for Diseases Associated with Exposure to Contaminants in the Water Supply at Camp Lejeune

VA to provide disability benefits for related diseases

WASHINGTON – The Department of Veterans Affairs (VA) regulations to establish presumptions for the service connection of eight diseases associated with exposure to contaminants in the water supply at Camp Lejeune, N.C. are effective as of today.

"Establishing these presumptions is a demonstration of our commitment to care for those who have served our Nation and have been exposed to harm as a result of that service," said Secretary of Veterans Affairs, Dr. David J. Shulkin. "The Camp Lejeune presumptions will make it easier for those Veterans to receive the care and benefits they earned."

The presumption of service connection applies to active duty, reserve and National Guard members who served at Camp Lejeune for a minimum of 30 days (cumulative) between August 1, 1953 and December 31, 1987, and are diagnosed with any of the following conditions:

Submitted by Bob Caggiano It is the right of every deceased Veteran to have a Military honors team attend the graveside service, to present the Flag at no charge to the family. Honors Teams are sent out, at the expense of the US Government.

In January 2000, Congress passed legislation guaranteeing Veterans the right to at least two uniformed servicemen, a flag ceremony, and the playing of TAPS at their funeral. Unfortunately, there are not enough buglers to play TAPS, so the historic melody has been played on a CD player at many Veterans' last ceremony, or more currently on a bugle that plays Taps using an electronic insert. The volunteer organization "Bugles Across America" (a.k.a. BAA) was created to honor the service of veterans by providing Taps live by a bugler using a real instrument (such as a bugle,

trumpet, cornet, or flugelhorn) at funerals or any other ceremony requiring a bugler. There are currently over 7500 volunteer buglers nationwide in all 50 states, and some overseas who stand ready to serve. BAA volunteers perform Taps as a free service.

As a Vietnam era veteran member of VVA Chapter 1002 and a BAA volunteer bugler, I am available to play for anyone who needs a bugler for Taps (or other appropriate bugle calls) for any honorable discharged veteran or related military ceremony.
