### AMANA NEWS AND NOTES

#### Fire Erupts in Golf Course Condo Helping Hands Make the Difference

The Amana Fire Department responded to a fire at the four unit condominium, Colony Oaks, at the Amana Colonies Golf Club, Friday, June 18 about 4:30 a.m.

Residents of the condo heard noises and smelled smoke, discovering a fire in progress and calling for help. The fire spread very quickly and the condo was fully engulfed when volunteers from the Amana Fire Department arrived minutes later. Mutual aid was received from volunteers in the Swisher, Fairfax, Norway, Williamsburg and Marengo Fire Departments all of which brought fire-fighting vehicles, equipment and water in response, reported Chris Herr, chief of the Amana Fire Department.

Four families were displaced. There were no reported injuries. Two pets had smoke inhalation and two dogs, pets of Curtis Sawin and Carolyn Wilcoxin, were killed in the blaze.

According to a news report on KGAN, Carolyn Wilcoxin, a resident of the second floor condo, was forced to escape by climbing onto the balcony and dropping into the arms of her neighbors. She was able to drop one of her dogs to safety.

The structure is a total loss with the garage, walls, rear and roof of the building destroyed, said Herr. Some possessions from the residences may be salvaged, though the apartments received heavy smoke and water damage. Cars in and around the structure were destroyed or heavily damaged.

"The fire appears to have started in the garage area but we do not know the cause," said Herr.

"We want to thank all of the volunteers and the departments who responded," said Herr who noted that over 40 firefighters worked together. He also was grateful for the prompt response of the lowa County emergency medical and safety personnel and the American Red Cross. The American Red Cross was called to the scene and provide immediate support to the victims.

By Friday evening through the efforts of family, friends and neighbors all four families had shelter, some clothes to wear and a few of the essentials they needed to carry on.

One of the fire victims, Terry Baugh, told friends afterward that the smoke detectors saved their lives.

Herr said that victims had the presence of mind to keep doors closed to their apartments thus helping to contain the fire and slow the spread and to use only safe exits to leave the building immediately. "Keeping the door closed between you and the fire is important. It buys you time to get out and helps to keep the fire out for as long as possible," he said.

A fund has been established at the Amana Church to assist all of the victims of the fire. Donations can be mailed to PO Box 103, Middle Amana, IA. 52307. Please indicate that the check is for the fire victims fund.





While there has been some rain this week, the conditions are very dry. Herr notes that most Class C fireworks – those that can be purchased by the layman – are especially dangerous in dry conditions because they emit plenty of sparks and often are fired on the ground. When shot in the air, they do not go high enough into the air to extinguish before hitting the ground. Special care, evaluation of the circumstances and great caution is required.

At the Amana Fireworks display on Sunday, July 4 the Amana Fire truck will be on hand and they will be shot above the Lily Lake. Also these fireworks go high enough into the air, so that they are fully extinguished before they hit grass or other things, Herr noted. The volunteers doing the firing are trained.

According to the Iowa Safety website: in Iowa it is legal to use fireworks June 1 – July 8 and December 10 – January 3. Fireworks are permissible to be fired off 9 a.m. until 10 p.m. and July 4 and the weekends immediately before and after July 4, until 11 p.m. Cities may have their own ordinances restricting fireworks.
