

MINUTES

MINUTES

COMMUNICATIONS & REPORTS

TREASURER'S REPORT

Joyce gave the Treasurer's Report which shows a balance of \$7,178.51. Expenditures were \$10.60 to Wanda; \$42.84 for Community Band postage; \$80 for Garnett Tourism Travel Guide and \$12 to the Garnett Publishing Company for Happy Ads. Revenue was \$1,636 for transient guest tax revenues for the juried art show.

CURATOR'S REPORT

In Sonia's absence, Joyce showed the members a collection of art and stands recently donated to WAC by Robert Cugno. The committee will need to unwrap and put the art away following Sonia's direction.

OLD BUSINESS

Marcia discussed the transient guest tax follow-up report which was submitted to the city for reimbursement. As noted in the treasurer's report, a total of \$1,636 has been received.

It was agreed to table discussion on the ambassador program until after school starts.

NEW BUSINESS

Candy Hewes introduced her daughter-in-law Nikki Sprague who visited with the committee about the possibility of having a display of photographs taken by her friend Karyn Sullivan of Manhattan. Nikki showed several pictures that Karyn had taken and the group was overwhelmed with the color and site selection. All photos have been taken in Kansas. The committee agreed that it would be great to have a display of these pictures in the west wing gallery. A motion was made by Wanda, seconded by Candy to plan a nice exhibit of these photographs. The motion was unanimously approved. Nikki will invite Karyn to
