Notice --- ALL Permits will be sold as MAIL IN ONLY --- Applications are available at Amana Society Main Office or High Amana Farm shop

When filling out application make sure to fill in all spaces required & allow a minimum of 2 weeks turnaround to receive permits.

If any State Regulations are broken & that State Revokes hunting or fishing privileges, ASI will revoke all privileges at least 2 times the State revocation period.

<p>+ Spouse and any children or grandchildren of Category 1 or 2 shareholders age 18 & under, or qualifying as full-time students age 23 and under may be classified at Category 2 .</p> <p>+ Any children of Category 3, age 18 and under, or full time students age 23 and under may be classified at Category 3.</p> <p>+ Amana Society Employee (Category 3) permits void upon termination of employment.</p> <p>+ Amana Society, Inc. employees who retire from the Amana Society after 10 years of full time service and then receive retirement benefits may be classified at "Category 3" during retirement.</p> <p>+++ For 2A & 2C Parent must be or Must have been a category 1 or 2 stockholder until time of death</p> <p>Category 1 & 2 Stockholders possessing a valid User permit will be allowed to have (max of 2) persons that are unable to qualify under any other category, in their company for activities that fall under the General User Category ONLY. Guests will not be allowed to participate in any of the other "hunting activities" with the accompanying stockholder. If a person qualifies under any of the current categories (2A, 2B, 3 or 4) they must purchase & possess a valid user permit and are not considered guests.</p> <p>** Must be accompanied by Category 2A or higher (Qualified stockholders may accompany a maximum of one individual at any one time for these activities)</p> <p>+ Resident - An individual with primary residence within confines of Amana Colonies Land Use District perimeter, also includes residences on 127th Dr. & 128th Dr. off of 27th Ave & any land that is Amana Society Service Company's Territory. Proof of residency may be required. Burden of proof is on the individual.</p>
<p>General User includes: Camping, Hiking, Fishing, Nuts & Mushrooms</p> <p>PERMIT REQUIRED FOR PEOPLE ALL AGES (Fees apply 16 and over). Camping requires user permit and is allowed in designated areas only 3 days in a 14 day period General User Permit & General Hunting Permit required to hunt game (Deer, Turkey & Waterfowl Additional)</p> <p>Millrace & its levees are a historic landmark, owned by the Amana Colonies Historic Sites Foundation. No ATV's permitted on the levee system other than bridge crossing. Please respect the rights of Landowner</p> <p>For safety purposes, all user and hunting privileges are invalid during shotgun deer hunting season except for licensed deer hunters for their particular season.</p> <p>These regulations are strictly enforced. Any flagrant violation of these regulations may result in the loss of these privileges and/or criminal prosecution.</p> <p>Hunting on the Lily Lake is prohibited.</p>

<p style="text-align: center;">GENERAL RULES</p> <p>ALL STATE AND FEDERAL LAWS INCLUDING AGE REQUIREMENTS, SEASONS, RESIDENCY, and LIMITS APPLY ON ASI LANDS UNLESS MADE MORE RESTRICTIVE BY THESE REGULATIONS. ANNUAL PERMITS VALID FROM DATE OF PURCHASE TO JANUARY 10TH OF THE FOLLOWING YEAR.</p> <p>No vehicles permitted on nature trail.</p> <p>Motorized vehicles, including ATV's, & horses are allowed on Established roadways/trails ONLY ! "Established roadways" are any established trail that is signified on map available upon request ! (State Handicapped Permits allow some access exceptions for motorized vehicles and ATV's) For ATV each Operator (regardless of age) must purchase their own Operator Permit. ATV Operation is allowed for Category 1, 2, 2A & Category 3 (Employee only) ATV Operation is allowed for Category 2B & 2C w/ Accompaniment by Category 1, 2 or 2A stockholder ATV's include: 3 & 4 wheelers, Ranger/Gator type, Motorcycles & Snowmobiles or vehicles of similar types Horseback riding allowed with General User Permit for Category 1 thru 4. No training of coon hounds on Amana property prior to hunting and trapping seasons as set by the Iowa DNR Deer permits are valid only for bow or any gun season. Turkey permits are valid for any turkey hunting seasons All tree stands must be tagged visibly with round Amana Society Inc. tags.</p> <p style="text-align: center;">Wood Cutting</p> <p>Only Downed trees and tops are allowed to be cut for firewood Cutting allowed for home use only, cutting for commercial use is not permitted. One permit is required per household. All individuals helping cut wood must have a general user permit. All other Amana Society, Inc. recreational land use regulations shall also apply to firewood cutting.</p> <p>Notice: These Special Deer Hunting Rules may differ from State Regulations: #1--In order to use antlerless early muzzleloader tags on ASI land you must have a State Anysex Early Muzzleloader season Tag. #2--You may only hunt during (1) of the Shotgun seasons (not both) #3--All deer must be checked in with a deer checker.</p> <p>Following 6 month of Employment (Cat 3) or new residents after 6 months of residency, permits may be issued</p> <p>Permits are issued for private, non-commercial use of holder only. Amana Society, Inc. reserves the right to amend these regulations at any time. The Amana Society hopes that you enjoy our lands, forests and waters.</p> <p>Any questions or comments ?
