## **Team House Update**


Last summer the Chapter formed a Team House Design Committee to begin working with an architect and builder to come up with a comprehensive plan to go from our empty lot to the grand opening of the preeminent Chapter Team House in the Special Forces Association. The Committee consisted of Chapter members Lee Vannes and Chuck Jenkins, along with the Boards of Officers from Chapter LX and TGBA, for a total of 11 Chapter members. The Committee evaluated several proposals and chose Bay Area Building Solutions as the builder and AI Collaborative as the architect. The plan that was subsequently developed consisted of three main phases.

Phase One was intended to produce a site plan for the property, a feasible floor plan and 3D sketches of the proposed building, and some photo-realistic drawings of the building and the site. The objective of this phase was to work with the architect and builder to create a feasible design that best met the initial requirements stated by the Chapter while taking in the limitations of the property and required code restrictions.

Phase Two is intended to be the fundraising phase, during which time the Chapter focuses on raising the funds needed to finalize the design and begin construction. The objective of this phase is to utilize the documents developed during Phase One to develop and execute a comprehensive fundraising campaign that will bring in the required funding. This phase is not time-dependent, but will conclude when the necessary funds have been raised.


Phase Three will finalize the design and complete the construction of the building and the site. The objective of this phase is to complete the site design and the interior/exterior building finishes, construct the building and associated structures (parking lot, etc.) and have TGBA take possession of the property for the Chapter.

Currently, we are nearing the end of Phase One, with only the photo-realistic drawings left to be completed. Here is the proposed site plan.



The building sits on the south end of the lot facing to the north for maximum visibility to vehicles entering MacDill AFB. The building will have a covered drive-up and dual flagpoles out front. The parking lot will have approximately 51 spaces including 2 handicapped spaces as required by code. The property will require a vault beneath the parking lot to hold runoff water due to the lack of available greenspace. A close up of the initial floor plan of the building can be seen on the next page.





The building is single story, approximately 6000 square feet in size, with a large event room capable of seating at least 80 pax, a smaller bar/ lounge area seating at least 40 pax, an outdoor patio area, office space, adequate bathroom facilities, a warming kitchen and storage space. Additionally both the large event room and bar/lounge area have retractable room dividers to enable the rooms to be divided for events as needed. The hallways, pre-function area, etc. should be spacious enough to allow for display cases and wall displays. A 3 dimensional drawing of the building looks something like this.



As with any construction project, issues will come up and decisions will have to be made that may result in changes to this original plan in a variety of ways. But this is the status of the Team House design effort up to this point. We should have the photo-realistic drawings in the next couple of weeks, and we will include them in a subsequent issue of the newsletter. At that point we will officially transition to Phase Two (fundraising) where the really hard work begins.

We will most likely form a Fundraising Committee to develop and discuss strategy, explore the use of professional fundraisers, organize fundraising events, and a host of other things. If you'd like to be part of that effort, contact a Chapter board member. And watch for continued updates in your newsletter!

## "Bane or Blessing"

"The soothing tongue is a tree of life, but a perverse tongue crushes the spirit."

Proverbs 15:4

The so called "Social Media" has become increasingly popular over these last years. Facebook, Twitter, and a host of other services support this new phenomenon. Individuals and families capitalize on the new technology to share family plans, triumphs and information with a wide variety of other family and friends. Such posts are a true blessing to those who participate.

Organizations and businesses invariably have a "Facebook" or some other page which replaces or enhances the more traditional website. These sites are essentially another means of marketing a product or service.

Social Media has also provided an inexpensive method for organizations to present their platforms and mobilize their adherents. Of course, these organizations run the gamut from religious, fraternal, charitable, to political. Some organizations are related to controversial subjects and span between advocacy and political action.

Social media during the most recent political campaign provided politician's opportunities to propound their policy positions and to vent their political bile. Unfortunately, civility was not often present.

As the Army dehumanizes the enemy to train its soldiers to kill other human beings, social media communications tend to impersonalize or even dehumanize its users, both sender and receiver. Just as it is easier to kill a dehumanized enemy who is identified by a denigrating name, so is it also easier to write impolite even hateful things to someone who espouses a position contrary to yours.

If the disagreement were to occur in face -to-face discussions, the antagonists would be able to make arguments not limited by 140 characters, to specifically address counter-arguments, to show nuance in the arguments, and to exercise self-control. Finally, people are more likely to maintain some degree of civility when personally interacting. On social media, such civility disappears. The lack of civility is incendiary and has cleaved asunder friendships and families. These characteristics are a bane of civilized society.

What can we do to minimize the negative effects of social media? Here are some ideas: First, do not allow your political positions primacy over your religious beliefs and familial ties. Maintain your perspective. Second, if you believe you must respond, keep your response focused on and limited to the argument at hand, not the individual. Do not respond in the heat of the moment. No ad hominem attacks. Third, never use images of others without their approval, especially in support of a political position. Finally, If the other party does not moderate the correspondence merely "unfriend" or "block" the antagonizing individual. Reading or responding to disagreeable posts is not worth the stress it creates.

Failure to follow these or similar guidelines may mark the correspondent as a person of little class and a troublemaker. Failure to follow these guidelines also harms the cause the user supports. No one likes a boor. Proverbs17:20 cautions, "One whose heart is corrupt does not prosper; one whose tongue is perverse falls into trouble."

## Requesting Military Personnel Records.

Have you lost your military service records, medical records, personnel records, or records of awards and medals earned? Are you a family member seeking information about the military service of a next-of-kin? Find out how to request information and what forms you will have to fill out.

Military.com Remember: your military records are normally free to request from the Federal Government, companies that advertise copies of your DD-214 or military records for a fee are scams.

Normally only the veteran or the nextof-kin may request copies of military records.

What Information Is Needed to Request Records

Your request must contain certain basic information to locate your service records. This information includes:

How to Request Service Information The National Archives online program eVetRecs is the preferred and fastest method for requesting service information. Provide as much information as possible in the comments field. Should you prefer to submit your request using a SF180 then provide as much information as possible and send the form to: National Personnel Records Center Military Personnel Records 1 Archives Drive St. Louis, MO 63138 Or Fax to: 314-801-9195

How Long Does It Take To Receive Copies of Records? According to the National Personnel Records Center 92% of separation record requests are processed within 10 days of receipt. However, health records may take longer. The eVetRecs website has instructions for emergency requests needing faster processing. (Note: If you have previously been told your records were destroyed in "the fire" you should request them again. Many records have been reconstructed.)

# Outside conservative groups entering the fight over VA health care reforms By: Leo Shane III October 23,2017

WASHINGTON — When House lawmakers start debate on massive reforms to the veterans' health care system this week, they won't just be hearing from veterans pushing for changes. A coalition of conservative groups typically not connected to Veterans Affairs issues sent a letter to House leaders on Monday pushing them to rein in department spending and shift more resources to private-sector medical appointments for veterans who want them. "Americans who put their lives on the line for our country should have the freedom to choose to use their VA benefits in the private health care market," the letter states. The effort — led by Concerned Veterans for America, a conservative voice in the veterans' community in recent years — includes Americans for Prosperity, Heritage Action for America, National Taxpayers Union, Tea Party Nation and 11 other groups with ties to Republican Party donors and small -government initiatives. It comes one day before the House Veterans' Affairs Committee is scheduled to start debate at 10 a.m. on Tuesday to discuss the potential health reforms. (mil.com)



# The Army Is Investigating The Pro-Communist West Point Grad.

The Army is "looking into" the West Point graduate and Afghanistan combat veteran who appeared to endorse communism

in social media posts, the U.S. Military Academy announced on Sept. 26.

A photo of 2nd Lt. Spenser Rapone in a West Point uni-form with a paper sign reading "Communism Will Win" tucked into his cover went viral with the hashtag #VeteransForKaepernick on Sept. 24. A self-described "commie/space cowboy," Rapone identifies himself as a member of the Democratic Socialists of America on his Twitter account. "Second Lieutenant Rapone's actions in no way reflect the values of the U.S. Military Academy or the U.S. Army," USMA said in a statement. "As figures of public trust, members of the military must exhibit exemplary conduct, and are prohibited from engaging in certain expressions of political speech in uniform." In a June 7 tweet, Rapone referred to Secretary of Defense James Mattis as "the most evil, vile f--k" in the Trump administration." (I hope the Army "looks into this" better than they did the Bergdahl desertion/treason case: Katz)



# Trump's VA secretary said to be interviewing for new post.

A long-awaited overhaul of veterans' health care is being unveiled to the world. At the helm throughout the two years of developing this road map has been David J. Shulkin. As the U.S. Department of Veterans Affairs is finally on the cusp of rolling out its master plan to ensure every veteran has access to timely, quality care, the VA secretary reportedly is interviewing for another job.

As the Wall Street Journal revealed, the White House brought Shulkin in to discuss having him take over the Department of Health and Human Services, a post left vacant by the abrupt resignation of Tom Price. (VA did not confirm or deny the Journal's reporting.) There is no doubt the top post at Health and Human Services is vital to every American, given the raging debate over the future of health-care insurance, certainly including veterans. There is little doubt Shulkin is qualified. But the timing is dangerous to the Department of Veterans Affairs and the millions of veterans who depend

The exemption listed below is very often not known or is misunderstood. Other than the exemption granted Florida veterans with a permanent and total disability, this is the most valuable exemption. If you qualify start now to obtain the requisite letter from the VA.

Florida Statutes 196.082 – Discounts for disabled veterans

Current as of: 2016 | Check for updates | Other versions

(1) Each veteran who is age 65 or older and is partially or totally permanently disabled shall receive a discount from the amount of the ad valorem tax otherwise owed on homestead property that the veteran owns and resides in if:


- (a) The disability was combat-related; and
- (b) The veteran was honorably discharged upon separation from military service.
- (2) The discount shall be in a percentage equal to the percentage of the veteran's permanent, service-connected disability as determined by the United States Department of Veterans Affairs.
- (3) To qualify for the discount granted under this section, an applicant must submit to the county property appraiser by March 1:
- (a) An official letter from the United States Department of Veterans Affairs which states the percentage of the veteran's service-connected disability and evidence that reasonably identifies the disability as combat-related; (b) A copy of the veteran's honorable discharge; and(c) Proof of age as of January 1 of the year to which the discount will apply.
