REGIONAL PLANNING REPORT:

No Hocking Township issues. This was the first face to face meeting since COVID. Loudan Klein is leaving and James Mako will be taking his place.

ZONING:

Inspector Marshall reported a total of 8 permits YTD. Mark Kifer for a new build on Wagnor, an accessory building for Tammy McGrady on Lancaster Circleville Road, a new build for Osborne on Westfall Road, a room addition for Steve Wolfe on Becks Knob Road, a new build for Jeff Myers on Windy Hills Circle, an addition for Parrish on Delmont Road, an ag building for Claypool on Lancaster Circleville Road, and two conditional use permits.

CORRESPONDENCE FROM THE FISCAL OFFICER:

Bid opening for the 2020 paving program. McKee and Shelly were the only two to submit sealed bids. After review from the trustees, McKee was the lowest bid. Trustee Shaw motioned to accept McKee Paving's bid and to award them the contract. Trustee Ellinger seconded the motion. Roll call vote Ellinger – Yes, Shaw– Yes. Motion approved. Minutes from the May Meeting being read prior by the Board were approved as read, so moved by Trustee Shaw and seconded by Trustee Ellinger. All were in favor with 2 ayes and no negative votes, motion passed. Budget meeting will be held after the regular meeting.

FIRE DEPARTMENT:

Fire Department reported monthly runs so far have been 13 fire and 43 EMS for a total of 367 runs YTD. Mutual aid was provided to Amanda, Berne, Clearcreek, Greenfield, and Lancaster. A total of 5 runs to SCI.

OLD BUSINESS

1. The county will keep Hocking Township informed as to the progress of the OPWC on Meister Road.
2. Hocking Township will continue to monitor Stonewall Cemetery Road and Stepath Mound Lane for erosion.
3. Health Department meeting was the first of March. There is a committee formed to work on some budget issues with them and to plan for the future.

NEW BUSINESS:

1. Riddle Forest Products want to log on an area on Hopewell Church Road. We are waiting on a ROW Agreement to be signed. Pictures have been taken of the road.
2. Spoke with McKee, Spires, and Shelly concerning the back of Stepath Mound Lane and the end of Stonewall Cemetery. Will be getting a quote to have a couple of those areas paved with a smaller paver.
3. Trustees scheduled Tuesday, June 30, 2020 to view the projected roads to be paved.


There being no further business to discuss Trustee Ellinger motioned to adjourn and Trustee Shaw seconded the motion.
