MEETING - JANUARY 12, 2012

The ATSSA governing Board of Management took the opportunity this meeting presented to conduct a review and exchange of ideas on the status of the ATSSA to date and to obtain approvals for motions going forward.

It was reported that financial reports were recently received from the branches, an encouraging



development moving forward. Unfortunately, it would appear from their web site that Kitchener has removed themselves from the ATSSA.

Also, the Board of Management recently received a 'notice to reader unaudited statement for 2010 & 2011' from the (former) management at the CFMS that shows considerable and untenable losses in each of the past two years. Concern for the health of the CFMS and the ATSSA; along with the inherent liability placed upon the

ATSSA Board of Management, OFFICERS and general membership; prompted the Board of Management to issue a notice to each ATSSA branch executive and their appointed CFMS committee representative, to cease and desist from any financial commitment of ATSSA assets to CFMS and to return all CFMS assets to the ATSSA parent chapter. As a consequence, CFMS operations have been suspended until a thorough review on its viability and structure is completed. The Board of Management, our President and others, has and will continue to meet and reach out to other Branch executives, members and sponsors; to review and exchange ideas, in order to evolve into a stronger and more effective, responsible and cohesive organisation; for our members and for our sponsors; for the ATSSA and the CFMS.

(Recap: The ATSSA was formed in Toronto in 1938 as a volunteer and not-for-profit organization. A Board of Management governance structure was established by the founding Toronto Chapter and registered incorporated charter holder (more commonly referred to as the Toronto ATS), with a constitution and by-laws formulated accordingly. The Toronto Chapter expanded the ATSSA organization to include the current network of Branches; while operating the CFMS jointly with the executive committee representative of each branch.).
