NOTICE INVITING TENDER (NIT) FOR SUPPLY OF RAW MATERIAL FOR HANDICRAFTS

Jharkhand Silk, Textile and Handicraft Development Corporation Limited (Jharcraft) invites sealed tenders from reputed firms/dealers for "Supply of Raw Materials for Handicrafts Products" for a period of one year from date of issuing order.

Selection Procedure: A double-stage two packages (Technical Bid & Financial Bid) system shall be adopted for selection of suitable bidder.

Eligibility Criteria: For eligibility criteria and other parameters, please refer to the Bid Documents.

Procurement of Bid Document: Bid documents can be procured from the office of the Managing Director, JHARCRAFT at the address given below on all working days from 10:00 AM to 6:00 PM from 02.02.19 to 22.02.19 on deposit of a non refundable demand draft of Rs. 5000/- drawn in favour of "Jharkhand Silk, Textile & Handicraft Development Corporation Limited" payable at Ranchi. Alternatively, bidder can also download the Bid document from the website: www.jharcraft.in In case of downloading of the bid documents, bidder/(s) has to submit the demand draft of same amount (non refundable) along with the bid.

Technical bid should comprise of following documents:

1. The tender shall be for the Handicrafts item(s) as per our requirement. The format for item wise price bid is specified in *Annexure- I & II respectively* , which should be used at the time of submission of tender.
2. Non-refundable Demand draft of Rs 5,000/- in the favour of Jharkhand Silk Textile & Handicraft Development Corporation Ltd. payable at Ranchi as tender fee for each annexure to be submitted with the price bid
3. The bidder should have experience of at least three years in supply of raw materials for dhokra & jute regarding that certificates, testimonial, bills, payments proof etc. to be enclosed.
4. The bidder should submit single price bid for all items mentioned in Annexure I & II and the single complete price of total items of respective annexure will be considered as L1.
5. The quoted rates shall include the excise duty and the bidder's cost towards insurance, packing & forwarding, transportation and delivery charges to 1. Jharcraft- Hehel unit near ITI Bus Stand, Ranchi. 2. Urban Haat, Hazaribagh, Jharkhand.
6. Tender should be properly signed and stamped
7. Self attested copies of income tax return of previous 3 years along with GST registration certificate.
8. Balance sheet for the last three years certified by practicing CA.
9. Earnest money deposit Rs. 25,000/- along with tender in favour of Jharkhand Silk, Textile and Handicraft Development Corporation Limited payable at Ranchi for each annexure.

Other terms and conditions:

- I. The financial offer should be inclusive of all taxes, duties, GST etc. and no additional payments shall be made to the tenderer over & above.
- II. Each bidder shall submit only one bid for all items and also can submit bid for one annexure also. Conditional offers shall not be accepted.
- III. The Prices shall be quoted in Indian Rupees only.
- IV. Jharcraft reserves the right to change, alter/modify the designs/layouts.
- V. Jharcraft reserves the right to cancel the contract/order on any reasonable ground/violation of contract etc. for which no compensation will be given.
- VI. In case of any dispute, courts in Ranchi will have jurisdiction.

Issue of Purchase Order

1. The Purchase Order will be placed to the selected bidder whose bids has been determined to be substantially responsive and who has offered the lowest evaluated item price (different work orders for different annexure). The terms of the accepted offer shall be incorporated in the purchase order. Order will be placed on item wise requirement basis for a period of one year from the date of acceptance of the principle order and price will remain unchanged during that period.



2. Payment shall be made on delivery of goods according to the supply order in support of production of bills and challan etc.
3. The tender will be opened in the presence of tenderer, if any, in the office chamber of Managing Director on 25.02.19.
4. Notwithstanding the above, the purchaser reserves the right to accept or reject any bid(s) and to cancel the bidding process at any time prior to the issue of Purchase Order.
5. Any legal dispute arising out of this is subject to Ranchi jurisdiction.

Tenders Document Submission

The applicant should submit bid/tender, technical and financial in two separate sealed envelopes, kept in third sealed envelope alongwith earnest money deposit in the form of demand draft.

- I. Envelope one should super scribe as technical bid for event management & fabrication for "Supply of Raw Materials for Handicrafts".
- II. Envelop two should also super scribe financial bid for event management & fabrication for "Supply of Raw Materials for Handicrafts".
- III. Third envelope should subscribe tender for event management & fabrication for "Supply of Raw Materials for Handicrafts".

The outer envelope should contain first two envelope of Technical & Financial bid.

Technical bid should superscribe NIT NO. & Tender for "Supply of Raw Materials for Handicrafts"

Financial bid: As per the annexure I & II for rate quotation.
