Please note that your attendance either remote, by proxy, or live will all be counted towards establishing our Quorum for the meeting. However, by signing up for the Remote Online Option, you'll be waiving your right to participate in certain activities that only those PCs attending live can participate in, including, but not limited to: Making motions, participating in any debate, voice voting, carrying another PC's proxy, giving your proxy to another PC, etc. That said, you will be voting on all items that officially appear on the Ballot via Simply Voting.
