## Committee News...

- We hope you can join us October 15th at 5pm for the Meat & Greet at the Pavillion. Bring your side dish and drinks and enjoy some of that fantastic Blue Moon BBQ!
- The Board approved the addition of 3500 triploid grass carp to address our hydrilla infestation and the permit was obtained from the Texas Parks and Wildlife. However, due to the excessive heat and high water temperatures, the delivery of the carp was delayed as the fisheries could not provide safe delivery. The carp were delivered on Wednesday, Oct 5th.

- Oil and Gas Committee reported Production is back up as well as prices. Our last check from Comstock was \$57,231.95. Average price was about \$7 / mcf.
- Comstock water agreement update: since the lake water level has dropped 12" below the top of the spill way, a letter was sent to Comstock informing them that they will not be allowed to draw water until sufficient rain raises the lake level. Comstock reported they do not plan to draw water until 4 th quarter if at all in 2022. No water transport facilities have been installed at Camp Creek Lake yet. We have purchased and installed a device to measure the lake level remotely and provides notifications of water level and temperature data to the board members responsible for monitoring.
- The CCWC Rules & Regulations Manual has been updated and distributed via email and is availalbe on the CCWC website. If you did not receive an email, please contact Sherry in the office to get an updated email contact address.
- Brazos WIFI provided an update that construction was delayed further for their high speed internet service.
- We were contacted by a lot owner voicing concern for the health of the deer stating they look like they are starving, and they are getting aggressive. The Texas Parks & Wildlife, who owns the statewide deer herd, recommendation for Camp Creek is to stop feeding them. They are wild animals and feeding them often reduces their instinct to forage for themselves.



# Lake Mgmt News

At the Board Meeting June 4, 2022, the Board approved the addition of 3500 triploid grass carp to address our hydrilla infestation and the permit was obtained from the Texas Parks and Wildlife. The Board also approved the spraying (w/ Aquathol K) of boat lanes and pathways with the intent of improving access around the lake during the summer months. This treatment was completed before the July 4th weekend. Solitude also sprayed the lotus plants in June and again in August in order to treat plants that surfaced later or that were originally missed in June.

## Additional Information:

Due to the excessive heat and high water temperatures, the fisheries would not deliver the carp as they would not survive the excessive heat so the additional carp were delayed until the heat and water temperatures allow for healthy delivery. Solitude's latest report dated August 16, 2022, reveals additional acreage of hydrilla which is likely due to the decreased water depth at the time of data collection. Some advantages may be realized from the low water level:

- The grass carp are more concentrated.

- Exposed shoreline areas will be hydrilla free for at least a brief period when the lake refills.

- Herbicide treatments will go further due to the decreased depth.

## On Wednesday, Oct 5th, 3500 carp were delivered and released into the lake.

As a reminder, we had stocked a total of 4000 triploid grass carp during 2021. If we account for the 4000 less 600 for the estimated mortality rate, the new total would be 6900 total carp (3400 + 3500). This would equal approximately 9 carp per surface acre using a total lake area of 750 acres.

There is a risk that at some point we will have to remove some carp to maintain an appropriate balance of lake vegetation, but herbicide treatment is expensive, temporary and not as effective in more open parts of the lake. It will take some time for the carp to eat down the hydrilla where noticeable changes can be seen, but the additional carp are now in the water.

# Important Reminders

## Safety First:

- **Life jackets are required for all tubers, skiers and anyone being pulled behind a watercraft. A \$250.00 fine will be assessed for those not wearing a life jacket as required!**
- Refrain from alcohol when operating a boat or jet ski.
- Do not pull tubes with people on them down the channels.
- Boats and jet skis must travel in a counterclockwise direction in the ski area.
- Stay in boat lanes when possible.
- No swimming at the boat ramps.
- Be mindful and courteous to others on the lake.
- Please remember all boats and jet skis must be registered and tagged.
- Only annual permit holder registered watercraft are allowed on the lake.
- Guests need a pass while on the lake, if they are not with a lot owner.
- The lake has many stumps so please travel in the boat lanes and be cautious in the water.
- Be careful swimming as hydrilla can be a safety hazard.
