10. CEO'S REPORT

Mike Fillette explained that there is currently a viral outbreak called Newcastle's Decease and it is primarily in Southern California, but the state wants the fair to be aware of it. At this point, both Larry Forero and I feel this should not affect the fair this year if at all. Discussion ensued.

A few weeks ago, we had a car and a truck there were chasing one another come through the fairgrounds and cause quite a bit of damage to fencing and a few other areas of the fairgrounds. It all started when they ran through the fence on Morgan Hill Road at Highway 3. Apparently, the driver was caught and arrested, and we are in the process of filing an insurance claim with the county for an estimated \$1,600 worth of damage. The storm over the past week caused a lot of damage to trees around the fairgrounds that you may or may not have noticed already. Some fencing is down and there was some damage to the horse barn. We will cut the downed trees into firewood and auction it off as a fundraiser later this year. Discussion ensued. Mike mentioned that the grant he was working on for the commercial kitchen did not pan out. He said he will

Mike mentioned that the grant he was working on for the commercial kitchen did not pan out. He said he will continue to look for grant opportunities that might help us with that project. Discussion ensued.

Mike said he has drafted a letter asking for additional assistance from the county. We are asking the county to waive the fair's solid waste fees, waive costs related to having the sheriff present at the fair as well as not paying for permitting fees on fairgrounds property. Mike said that he has also asked the county to have the fair included in their legal council contract. Discussion ensued.

CFSA has a loan program and a line of credit for California fairs. The interest is 6.4% if we applied now. Discussion ensued.

Mike said the fair may have more deferred maintenance money coming in shortly. In 2015, then fair manager and CEO Ben Duhem completed a survey of what needed to be done around the fairgrounds, but the list was not very accurate. Since then, the state has asked me to complete another survey in which we will need to choose 5 of the most important projects that need to be completed and submit those for consideration.
