Adam Dombchik – All appropriate forms for workers comp need to be filled out. Workers comp running okay, a little faster than usual.

Erik Schwartz - Workers comp using all 90 days to make decisions.

Jacob Kalinski (RLS) – Order of mandating personnel for vaccine. They would be able to mandate vaccine. Two concerns.

Cautious of liability, side affects Legal hurdles with religion and health condition.

Rob Wexler (RLS) – Flyer distributed for two-hour webinar on Use of Force.

Maurice Sinsley (Stone Busailah) – Cities are moving quickly for citizen review committees. Independent auditors for citizen complaints, Use of Force investigations, and trying to be in interviews.

Robert Baumann (Adams/Ferrone) – Fitness for duty, trying to circumvent process if discipline is an issue. Get legal representation involved quickly if hit with a fitness for duty claim.

John Ferrone (Adams/Ferrone) – Light duty fraud is becoming more and more a topic. PTSD is presumptive. Slow uptick in cities hiring law firms to get reevaluation on medical retirees under the age of 50.

Howard Liberman (Mastagni) – Personal Liability Insurance. SB 16 is creating quicker termination for Police Chiefs and Sheriffs.
