#### **Board Reports:**

## President's Report - Mike Johnson

Signs: Discussed the plan to add new No Trespassing Signs in 22 locations on the common properties. Jan Richardson will contact the sign company used previously to get an example of the proposed sign. It was agreed that the No Trespassing should be in red. These signs will be 10" X 14", and will be installed in 22 locations around the common properties. 25 signs will be ordered once the design is approved.

Matt Burdette suggested contacting the Denver Water Board about the "No Wading or Swimming signs to see if they have a standard sign that is used on their properties.

Jill Cochran reported that there were 2 new owners since the last meeting.

#### **Lakes and Fishing Committee Report**

Ken Richardson reported: that

- Solitude came last week and found new issues with the compressors.
  But, they were able to get half of them working so the aerators are
  working on the North end of the lake. They will need to order parts, and
  when they arrive they will come back out to fix the remaining compressors.
  The cost of the repairs will not be paid until all aerators are working
  properly.
- The next fish delivery will be 7/5 as that was the only date available before the Derby. Per Liley the fish added to Potty Pond will be fine for the Derby. No Fishing Signs will be posted after the delivery at Potty Pond.
- The boat for hazing the Pelicans has been placed in the cabinet on the left side of the island. The key is in the Fish Patrol cabinet. Ken Richardson had a situation with the boat getting stuck in the middle of the lake. He had to borrow a kayak to retrieve it. The Richardson's offered their boat to be stored at the lake for these types of situations, or for repairs since the SVPORC boat was stolen which the Board approved.
- He is in the process of installing the links for locking the boats.
- It was determined the florescent paint recommended for marking posts was too bright. Foam tubes will be used, which Doug Coleridge will donate.

# **Covenants Committee Report**

Jan Richardson reported that 3 violation letters were recently sent certified; 1 owner is working on compliance; and 1 needing further research before a violation letter is sent.

## **Architectural Committee Report**

Doug Coleridge is working with Teller County concerning a county violation. Painting issue should be completed by 6/20, which has been delayed due to weather, and coordinating the work to be done with a family member.

## **Legal Affairs Committee**

Jan Richardson reported that she is working with the Secretary of State concerning the requirement to register with DORA.

#### **Other Business**

- Mike Johnson and Doug Coleridge requested to be copied on the Homeowner Balance Listing so they can address owners when they are on the common properties.
- Mike Johnson requested to have something that identifies that he is a Board Member. Jan Richardson will provide badges for all Board Members.
- Jan Richardson reported that 9 individuals had expressed interest if volunteering for the NoFloCo posse. She is waiting for a response for the next step from the organizer of the NoFloCo.
- Jan Richardson presented the addition to the Pavilion Rules and Guidelines to show the policy if the fireplace is used, which was approved by the 5 Board Members in attendance. The new policy will be added to the website, and posted where necessary.
