Although we are closer to having access the River, Federally designated as a "Wild and Scenic River" in 1985, we still need final approval from Board. Did you know there are only two Wild and Scenic Rivers in Florida, with the Loxahatchee being the first?

We need to demonstrate to the Board we have the money to proceed.

Equity Members: You are the heart of the club. Because of our equity members we will be able demonstrate to the Riverbend Condominium Board that we have the financing in place to achieve the dream of having access to this wonderful waterway. The number of equity memberships may be limited and time is of the essence. **We need your funds soon.**

\$2,500.00: \$1,250.00 November 30th and \$1,250.00 December 30th. Equity members will be required to pay a \$100.00 annual membership fee, which will be **waived the first year.**

Equity members may have an opportunity to own their own vessel.

Equity membership is fully assignable; renters of your unit may take full advantage of it.
