





MINUTES **April 2, 2017**

The Annual Meeting of the Katahdin German Shorthaired Pointer Club of Greater Portland was held on Sunday April 2, 2017 at The Red Blazer in Concord, NH. In attendance were Steve Marcq, Pauline Marcq, Susan Fuller, Megan Arey, Ben Arey, Gerry Braun, Dave Braun and Pat Russell. Following a delightful buffet brunch, the meeting commenced at 11 am.

President's Report: Lots of activities scheduled for 2017, which will be covered in the meeting. Steve reported on the status of HELDCA, which is responsible for the Sharpe's Farm grounds we use for our activities. We are still looking for a HELDCA delegate – someone to attend the quarterly meetings in Hopkinton, NH. The Sharpe's Farm clean-up day is scheduled for April 30. If any members is interested in learning how to post pictures to our website he is always happy to walk them through the process.

Secretary's Report: Pat reported on membership renewals – dues have all been paid, with the exception of two members who have dropped out. She reported on a ballot from the GSPCA asking for the club's vote on parent club officer positions. She will send out an email to members asking their preferences and vote as directed. She also reported that there is a Facebook page for German Shorthaired Pointers New England. It is a small group, but she has joined and will publicize Katahdin activities there.

Treasurer's Report: Jeremy was unable to attend, but sent in a report. We continue to maintain a healthy balance, ahead of last year.

New Members: None

Show Committee: We are all set with our Specialty on May 27th at the New England Sporting Group Association show in Swanzey, NH.

Hunt Test Committee: We will be holding a double header with the Northern New England Brittany Club the weekend of September 16 and 17. Katahdin will do a double header on Saturday and NNEBC will hold theirs on Sunday. Save the date, as we always need volunteers even if you aren't entered!

Water Test: We are holding our GSPCA Water Test later this year than previously – August 20th, with a training day on the 19th. We discussed whether or not to continue to hold the AKC water test following the GSPCA test, since we haven't had many attendees. It was voted to continue to hold the AKC test. It was voted to approve the purchase of an additional Ez Up and another Winger Zinger.

Training Days: We will be putting out more information on training days. We are looking at dates and possible guest speakers. We might have one day for JH dogs and another day for SH/MH dogs.

Election of Officers: The offices of Vice President and Secretary were up for election. The Nominating Committee recommended Cassandra Tompkins as Vice President and Pat Russell as Secretary. Upon motion made and seconded, the slate was unanimously approved.

Old Business: None

New Business: Megan Arey reported on a strain on Lyme disease that affects the liver and kidneys, and puts the dogs in liver and kidney failure. It causes personality changes, vomiting, urine in blood and high creatinine levels. Something to be aware of, as it apparently a strain previously not common in our area.

The meeting adjourned at 11:50 AM.
