



PPPA Judges Education Committee Presenter and Mentor Requirements

General Requirements:

- 1. Be a PPPA member in good standing
- 2. Have effective communication skills
- 3. Have a pleasing, clean, tidy appearance
- 4. Applicant must meet at least four (4) of the criteria listed below.
- 5. Have all dogs used in Judges Education clean and in good condition.
- 6. Candidates wishing to become a Judges Education Presenter or Mentor will be approved by the Board of Directors.

Criteria:

- 1. Have at least 3 years active PPP exhibiting experience with 3 years' experience in breeding PPP and have whelped at least 3 litters.
- 2. Applicants who meet the above guidelines must attend at least two (2) PPP Judges Education seminars.
- 3. Applicants must have championed five (5) dogs or bred three (3) dogs they have championed.
- 4. Applicants who meet the guidelines must pass an open-book test on the breed standard and, when possible, a hands-on test examining 4 or more exhibits, rank ordering them, and justifying placements. The tests will be administered by an approved Judges Education Presenter.
- 5. Participation in PPPA education events (brought dogs for Hands-on, participated in Meet the Breeds, etc.)
