TERMS OF AGREEMENT:

Parties: This agreement is executed on the Registration Date shown above, by and between Everest World Class TaeKwonDo, 8631 Walther Blvd, Parkville, MD 21236, herein referred to as the Academy, the Parent/Guardian, who's signature is affixed hereto, herein referred to as the Buyer.

The Academy: shall provide qualified Instructors and use of its facility (including time for supervised games and organized sports and party) for a period of time not to exceed 2 hours (not including setup/cleanup time)

The Buyer: shall provide all additional party supplies (i.e.: cake and/or food, decorations, paper goods, etc.), clean-up party room and agree to abide by all the rules and regulations of the Academy.

Permission Slips: It is understood that the Buyer must provide the Academy with signed permission slips for all guest participants from guest parents or guardians.

The Balance Due: is due on the day of the Birthday Party, prior to or immediately after its conclusion.

Liability: I, the undersigned Buyer, hereby acknowledge that I am aware of the strenuous physical exercise involved in the participation of the Martial Arts Birthday Party given by the Academy. I hereby consent to hold the Academy, its employees, instructors, and representatives free of any and all liability, claims, or actions whatsoever, arising from any injuries, accidents, illness, etc., due to the attendance at the Academy.

Emergency Release: I, the undersigned Buyer, hereby consent to allow the Academy to take such actions as it deems necessary to contact and provide emergency and medical assistance for the afore specified Birthday Child.

Media: I, the undersigned Buyer, irrevocably authorize the Academy, its successors, assigns and those acting under its authority, to copyright, use, publish for art, advertising, trade, or any other lawful purpose whatsoever, photographic portraits, pictures, and video in which the Buyer or Birthday Child is in whole or in part.

Gratuity: At least \$20 gratuity is required for each instructor (not included in the total Birthday Fee)
