## **Grant Applications:**

- To consider grant applications submitted:
  - a) Mirfield Veterans Bowling Club Graham Wilson & Ray Gowan gave representation for the application. Graham explains that the grant is required to build a shelter for spectators & players for shelter from the elements. Cllr Bolt asks about the existing porta cabins and their use. Graham confirms that these are used for storage & serving refreshments. Cllrs J Taylor & Pinder ask how many paying members & frequency of matches. Graham confirms that they have 35 paying members and that matches are played in the evenings, Probus Club & Monday – Friday 3 matches per week x 2 teams practice matches plus other matches, over 100 approximately. Cllr K Taylor asks if they have sought planning permission for a permanent structure Graham states they have not but will look into this and thanks Cllr Taylor for mentioning this. Cllr Hamilton asks if they receive subs and as the club has £4000 cash on hand, why they need a grant. Ray confirms that this money is for contingency if at any time they have to pay rent on the green etc. Cllr Lees-Hamilton states that this is a good project and felt that the shelters would be much needed due to the fact that the cabinet members of Kirklees council have reneged on their

promise to provide an indoor bowling facility within the new sports centre at Huddersfield. Cllr Bolt Proposed £1600.00 grant and stated MTC should support this venture Cllr Pinder Seconded Vote: All in favour Graham & Ray thanked MTC and left with a cheque for £1600.00 8.00pm.

He states that the drainage report has not yet been done and is unlikely to proceed free of charge due to internal disagreements at the drainage company. He confirms a conversation with Adam Cockroft regarding a possible letter from Kirklees confirming that the drainage pipe has not been inspected by either MTC or Kirklees and attach this to the lease. Cllr Pinder to speak to Matthew Garbutt regarding this, any updates to be circulated by email and bring conclusion to next meeting to sign the lease. Cllr Pinder would like it noting in the minutes that Mr Atkins Commissioner of Oaths waived the £5 fee

- as a gesture of goodwill.
