

Wisconsin Amaranth Trip to Milwaukee County Domes Saturday, August 30, 2014

Please note the change in the date from the original announcement in our installation program due to maintenance work on the facility. Sorry no buses are available so you will travel by private auto, but there is plenty of parking space.

Directions on getting there are:

Take I94 to the 35^{th} Street exit. Go south to National Drive. Turn left (east) and go 8 blocks to Layton Boulevard (27^{th} Street). Turn left (north) for $1\frac{1}{2}$ blocks and there it is on your right. If you cross the bridge, you have gone too far.

Arrival time is 8:30 am so we go in as a group. This is under Grand Court of Wisconsin, but non-members, relatives and friends are welcome. (We would like to see a large crowd). It is an adult excursion so no one under 12 is to be included. The price per person is \$10.00. When making your reservations make a check out to LEWIS CHRISTIANSEN, 229 Willow Lane, South Milwaukee, WI 53172. Reservations are a must and due on August 15, 2014, to give the facility time to make preparations. Sorry no rebates. There are plenty of places to rest when you get tired.

When we arrive there will be a short talk about "The Domes." Then we will be guided to the three domes. There are plenty of places to rest when you get tired. After that we will meet in the restaurant area for refreshments (at your own expense). Bring along some money for that and to buy gifts, plants, etc. After eating you are welcome to revisit areas you are interested in seeing again. You are welcome to stay the entire day if you wish. Dress is casual street clothes and good walking shoes.

Come prepared to have a good and interesting time. Hope to see you there.

<u>Milwaukee Icons</u>: <u>Mitchell Park Domes</u> is the star of the show from the designs to the architecture and plants with interesting stores about all the people connected to the domes followed by tour time in the domes.

<u>Mitchell Park: Past, Present, Future</u>: Learn how the park evolved from a trading post to the Mitchell's to a horticultural destination and farmers' market.

The Domes are truly one-of-a-kind! Here is a sampling of what you will see...

Lobby And Show: History of Domes and Design of the Domes. Enter a themed floral exhibit filling the Floral Show Dome with gardens of color. Five seasonal displays each year will delight you with their beauty and will serve to inspire your own gardens.

Arid (Desert): Come to the deserts of Africa, Madagascar, South America and North America in the Desert Dome where one of the world's finest collections of cacti, succulents, shrubs and arid-land bulbs grow. An Oasis of desert palms beckons as paths lead you past many plant oddities with intriguing geometric forms, subtle coloration and unique adaptations to hot, dry habitats.

Tropical Domes: Stroll the jungle-like trails of the Tropical Dome and see a rich diversity of plants from the rain forests of five continents. Showy flowers, fruits, nuts, spices and a multitude of orchids and bromeliads surround you as you're drawn toward a rushing waterfall in this paradise. Be sure to look for the colorful birds that call the Tropical Dome their home.
