The fair takes place at the Lake County Fairgrounds which is about one mile off State Highway 61, on County Road 2.

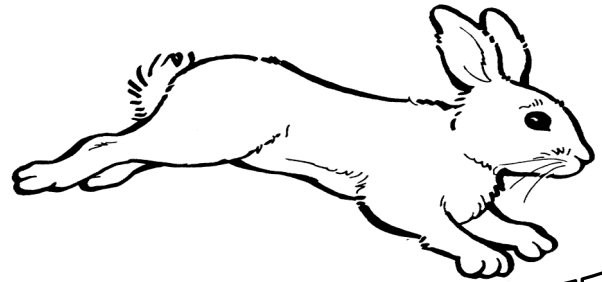
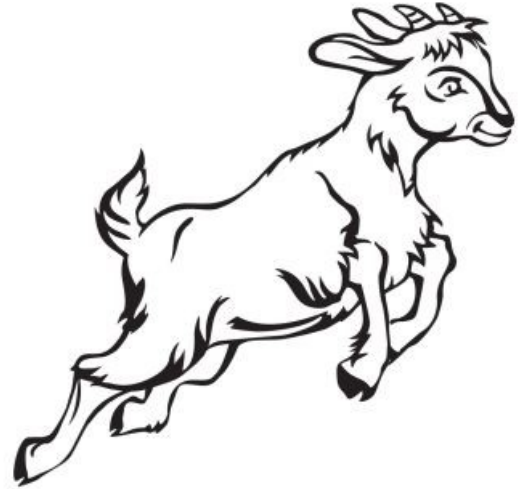
#### Directions:

# Exhibitors Rules

## Section 1:

The Lake County Fair management reserves the final and absolute right to interpret these rules and regulations and to arbitrarily settle and determine all matters, questions and differences in regard thereto, or otherwise arising out of, connected with or incident to the Fair.

## Section 2:

The management reserves the right to amend or add to these rules as they, in their judgment, may deem advisable.

## Section 3:

Any person who violates any of the following, or other special rules, will forfeit all privileges and premiums and be subject to a penalty as the governing body may order.

## Section 4:

The management will endeavor to accommodate exhibitors and to arrange for space for all qualified exhibits. The management reserves the right to limit the number of entries and in the event that present accommodations are exhausted, the management reserves the right to close entries at any time.

## Section 5:

The management will not assume any responsibility for disease, injury, loss or damage to exhibits during the fair.

## Section 6:

No person will be permitted to distribute advertising literature on the grounds except from within their booth. The tacking or posting of any advertisements or distribution of cards, fliers, etc. except within the space occupied by the exhibitor is prohibited. Anyone violating these rules will be liable to a fine and expulsion from the grounds, as the Board of Directors may elect.

## Section 7:

The management will not be responsible for typographical errors in this list, but should any occur, same will be interpreted by the Board of Directors.

## Section 8:

All checks must be cashed within 30 days after the end of the Fair or they will become void.

## Section 9:

All rules pertain to premium book /current year's fair.

# Division A Fine Arts

All entries must be photos taken since last year's County Fair. (This is for all photography). None larger than 5x7. A Professional/Commercial photographer is defined as one who sells or teaches for financial gain. Note: More than one (1) photo on the board is considered a photo story. Digital Photography: We are trusting in exhibitors integrity that photographs will be taken by you and not downloaded from the internet. **FINE ARTS** Pictures should be framed or matted and wired for hanging. This is all pictures (drawing, painting, etc.)

## Digital Arts Lots 15-18 and Lots 29-32

### 1. Digital Photographic Compositing

Digital Photographic Compositing is the use of photographic images from a variety of shots utilized to create the final scene. The final piece could be a collage or take on the feel of a surrealistic photographic scene. However, the final piece must be photographic in nature.

### 2. Photo Manipulation

Photographic sources altered with digital special effects or filters. Images for this category are for work that could look photographic, abstract or painterly. The process should entail photographic image or images where digital effects and filters are used to go beyond a photographic look. Appropriate techniques include digital images with more sophisticated layering techniques of imagery, photos smudged or cloned to look like paintings but which maintain the composition of the original photographs, filter effects on digital photos or modifications of color, such as posterizing, extreme saturation or de-saturation.

### 3. Painting and Illustration

Images created from scratch in a digital program; Photoshop, Illustrator or Freehand. Original work, primarily not from manipulated photographs. Photos may be used as reference but may not be a noticeable element of the final composition or layout. If any part of the image is photographic, or if it is a photograph manipulated to look like a painting, it should be placed into Photo Manipulation.

Work may be painted, drawn and contain abstract imagery that reflects originality.

### 4. Digital Panoramic

Images stitched together using programs like Photoshop, Autopano and PT Gui to create a single vision of a photographic theme. The size of the mat board may be any size to 24" maximum on the longest side. The final presentation could be an elongated vertical (long and narrow), horizontal or square, with a maximum of 24" in any direction.

## Division B Home Arts

The purpose of every exhibit is educational. If we do not learn how to better our work from an exhibit, then it has not fulfilled its purpose. Keeping this in mind, our list of premiums offered has been limited to such that help educate. Every person in the state of Minnesota should say, "This is my Fair and I wish to make the best we have had, so I shall exhibit some of my best work made during this year." It is only this way that the right exhibits can be shown and our Fair will be a wonderful success if we all try to make it so. The fine work done in our homes can be shown in our exhibits in this division. Bring your best!

### SPECIAL RULES:

1. Entry tags should, in every instance, be attached to articles before they are exhibited.
2. Exhibits **MUST BE THE HANDIWORK OF** and owned by the exhibitor.
3. **AN ARTICLE WHICH HAS RECEIVED A PREMIUM AT A PREVIOUS FAIR WILL NOT BE ELIGIBLE TO COMPETE.**
4. No person can enter more than one article under same lot number in any class, except in collections or sets.
5. Professional-Those who teach for remuneration or sell their work as a means of financial gain shall be considered a professional and cannot exhibit in classes or lots other than the **PROFESSIONAL CLASS**.
6. Judges are instructed not to award premiums for unworthy articles or on any article borrowed, purchased or previously entered.
7. **SOILED** or **UNFINISHED** articles will not be received by this division.
8. The management of Lake County Fair believes that all articles exhibited should have some educational value. It, therefore, reserves the right to exclude any article not scoring 70% or better.
9. Any article entered but not found in the premium list may be accepted at the discretion of the management. This rule must be enforced.
10. All articles must have been made or completed since last year's County Fair.
11. No entries will be judged and displayed in plastic bags, with the exception of baked and dried foods.
12. Any hanging articles must be equipped with a method of hanging.

# Division D Agriculture

NOTE: ALL VEGETABLES MUST BE CORRECTLY LABELED WITH THE NAME OF VARIETY.

## GARDEN VEGETABLES

Note: Prepare vegetables as described.

- Snap Beans, Peas, Green Beans-Harvest before constrictions appear between seeds, when seeds are about half-grown. Ends of pods should not be broken off in picking. Pods should be uniform. Pods may be wiped clean but not washed.
- Beets, Carrots, Parsnips, Rutabagas-Root crops should be mature but not overgrown, pithy or coarse in texture. Tips trimmed off 1 1/2 inches above crown. Side roots trimmed off but not the tip root. Roots are carefully washed but not scrubbed.
- Broccoli-Heads should be dark or purplish green cut 5 inches from top of head.
- Cabbage-Stems cut about 1/4 inch below the head. Remove blemished or broken leaves but care should be taken not to peel the heads too much. A few outside wrapper leaves are desirable. Specimens may be washed.
- Cauliflower-Heads should be white, compact and free of small leaves and ricey texture. Stems cut so as to leave 4 to 6 leaves. Outer leaves trimmed 1-2 inches above the white head. Use soft bristled brush to remove the dirt from the heads.
- Celery-Remove roots of stalk/plant and trim butt to form a triangle or pyramid. Trim disease and broken leaves on outside until color is uniform.
- Sweet Corn-Select ears that are well filled out to the tip. Kernels should be milky and juicy. Remove outer husks but allow a short shank and inner husks with silks to remain.
- Cucumbers-Pickling: Select fruits 3-5 inches long. Specimens should be the same stage of maturity and uniform in size, shape and color. Slicers: Select fruits that are straight, dark-green and 6-10 inches long. They should be uniform in size, shape and color. Do not wash off the spines.
- Kohlrabi-Roots moved just below the ball. Remove all but the upper 4-6 leaves. Select specimens that are uniform, medium size and not hard or woody. Skin should be easily punctured by thumbnail. They should be clean but not washed.
- Onions-Have specimens mature and thoroughly cures. The neck should be small. Only such outer scales that are broken or discolored should be removed. Small basal roots should be left intact but trimmed to a uniform length of 1/2 inch. Wipe or brush but do not wash. Trim green onions to 6-8 inches.
- Rhubarb-Select specimens that are straight, uniform and unblemished. Stalks should be pulled from the plant, not cut. Trim leaf blade to about one inch above the stalk.
- Summer Squash-Select small to medium size fruits when the rind is soft and easily punctured with thumbnail. Leave about 1/2 inch of stem and wipe fruits clean.
- Winter Squash and Pumpkins-Select mature specimens where the rind resists the pressure of the thumbnail. Fruit should be free of defects. Leave stems attached to the fruits.
- Swiss Chard-Select plants that are fresh, crisp and have bright green leaves. Trim off roots and trim butts to a pyramid shape. Trim off diseased and broken leaves on the outside until the color is uniform.

# Division K Livestock

Livestock and poultry that exhibit symptoms of any infectious or communicable disease, including ringworm and warts, may not be exhibited. All animals must be examined by the official veterinarian on the day they are admitted to the exhibition and at least once during the exhibition. It is recommended to have all veterinarian records on site.

**CATTLE AND BISON** – For import, Exhibition and Movement within Minnesota USDA Metal Tag-Begins '41', USDA Brucellosis “Bangs” Tag, 840 RFID and Non-RFID Tags, Plastic '41' Tag-New alternative to USDA metal tag, Breed Registry Tattoos: Breed Registry Tattoos are acceptable if accompanied by a breed registration number or a veterinarian statement such as “this animal is registered with the (insert breed association here).” Pending registrations are not acceptable.

**SHEEP and GOATS** - Sheep and goats must be identified with official identification approved for use in the scrapie eradication program.

**SWINE** - Swine must be individually identified and must: (1) have had a negative official pseudo rabies test conducted within 30 days prior to the opening date of the exhibition; or (2) originate directly from a qualified pseudo rabies-negative herd; or (3) originate directly from a Stage IV or V county or area. All 50 states are currently pseudo rabies Stage V (Pseudo rabies Free Status).

**HORSES** - All horses must be negative to an official test for Equine Infectious Anemia (EIA) within 12 months prior to the opening date of the exhibition. A test is not required for suckling foals accompanying a negative dam. Original—current Coggins required on site at all times.

**POULTRY** - Poultry, except waterfowl and pigeons, must be individually identified with a leg or wing band and accompanied by a form approved by the board to show compliance with one of the following: negative test for pullorum-typhoid disease conducted within 90 days prior to the opening date of the exhibition; originate directly from parent stock tested and found negative for pullorum-typhoid disease within the last 12 months. In addition, turkeys must be tested negative or originate directly from parent stock that is tested negative for *Salmonella typhimurium*, *Mycoplasma gallisepticum*, and *Mycoplasma synoviae*.

**2019 Lake County Fair-Poultry exhibits will be limited to two birds per exhibitor. This ruling was made due to the shortage of the *Salmonella* Pullorum plate antigen used to test poultry in the field for Pullorum-typhoid disease with the Rapid Whole Blood Test (RWBT) If you are able to obtain a statement of origin for birds hatched after January 1st of this year, and purchased from a pullorum typhoid free hatchery, please do so, as antigen is limited for testing. (waterfowl, ducks and geese, do not fall under this ruling, they do not require testing)**

**DOGS** - Dogs over six months of age must be accompanied by a certificate of rabies vaccination issued by a licensed veterinarian.

**IMPORTED ANIMALS** - All imported animals must be accompanied by a certificate of veterinary inspection and meet the Board's importation requirements.

**SLAUGHTER CLASSES** - All livestock and poultry entered in the class which are kept isolated in a separate building from all other livestock and poultry at the exhibition and which are slaughtered during or immediately following the exhibition do not need tests or individual identification.

**CERVIDAE** - Brucellosis-Negative brucellosis test within 90 days prior to entry on all cervidae over 6 months of age except: Cervidae originating from a negative brucellosis whole herd tested within the last 12 months (date of last test to be available) or from certified brucellosis free herd.

Tuberculosis-Negative tuberculosis-negative test within 90 days prior to entry on all Cervidae over 6 months of age except: Cervidae originating from a negative tuberculosis whole herd tested within the last 12 months (date of last test to be available) or from certified tuberculosis free herd.

# Division K Livestock

## LIVESTOCK AND POULTRY LIVESTOCK RULES AND HEALTH REQUIREMENTS

All livestock exhibited must comply with Minnesota Livestock Sanitary Board and Fair Board requirements (some types may be checked entry). Consult your veterinarian, and follow health requirements listed below. Horse exhibitors must show proof of Negative Coggins test (no copies allowed, originals only). Poultry disease testing can be done before the fair by contacting Ryan Williams through the fair board [lcasfrbrd@hotmail.com](mailto:lcasfrbrd@hotmail.com) or 218-355-0408 (turkeys 90 days before the fair) Chickens can be tested at the fair at entry time. All tests must be made within 90 days of exhibiting.

### RULES:

1. If livestock becomes a problem while showing or exhibiting, the barn boss and/or livestock superintendent has the right to send the animal home or confine to pen.
2. All livestock and poultry should be in place by 8:00 a.m. on the first day of the fair day, as judging may take place later on the same day.
3. An exhibitor CANNOT enter more than one (1) entry in any given lot in each class.
4. All animals will be judged in blue, red or white ribbon groups according to quality of animals. Judges are not obligated to place any animals in blue group if no animals qualify. If no red ribbon animals are exhibited, the judges need not place any animals in the group, etc.
5. Removal of livestock between 6:00 p.m.-8 p.m. Sunday of the Fair if animals are removed early or the stalls/cages are not cleaned PREMIUM CHECKS WILL BE HELD. Animals may not be removed early without Barn Bosses and Livestock Superintendents' knowledge & approval. (Approval form must be signed by Barn Boss or Livestock Superintendent, 4-H representative does not have authority to make this decision.)
6. Premium checks will be held until stall is cleaned to satisfaction of barn boss or superintendent. Any rubber mats used in stall are the sole responsibility of exhibitor and must be removed and cleaned by exhibitor.
7. Any veterinary services required at the fair will be the sole responsibility of the animal's owner - - not the Fair Board.
8. No stallions (except minis) or bulls over 6 months old may be entered in the fair, unless cleared through a barn boss.
9. No boars, billy or buck goats over 6 months old may be entered in the fair, unless cleared through barn bosses.
10. All registered animals must be registered in the owner or lessee's name.
11. Exhibits will be judged by breeds and age groups.
12. Stalls and animals must be kept in show condition at all times. Failure to do so will result in loss of premiums.
13. Diseased animals or poultry will be sent home for everyone's protection.
14. 4-H exhibits will not take precedence over open class It will be first registered, first served.
15. Livestock information must be posted with animal (breed, age, open class or 4-H, etc.)
16. Game Farm License number must be shown to register any animal or poultry requiring such.
17. Order of load out will be at the barn bosses discretion.
18. Stall and cage assignment will be decided by the Barn Committee (Livestock Superintendents and/or Barn Bosses). (First come, first served, unless reserved ahead of time through barn committee.)
19. ALL exhibitors must register for barn space, ahead of time, when possible.
20. Livestock including horses not staying in barn for duration of fair may not use the barn/stalls at any time during the fair or shows. This includes wash racks in rear of livestock barn.
21. Exhibitors living in Lake County or in the Lake Superior School District will have priority for remaining barn space.
22. Exhibitors must place animals in barn, but may ask for assistance.
23. Cattle, horses, sheep and goats, etc. must be led by exhibitor for judging outside the pen if requested.
24. No ferrets, weasels or minks (mustelidae family) are allowed on fairgrounds except if entered in pet show; animal may be present on grounds for duration of said show only.
25. No animals are allowed to be tied to or outside of stalls during open barn hours which are 8 am to 10 pm.
26. All animals in Howard Solem Barn will need to be taken in and out of back door only at all times, unless approved by Barns Bosses and/or Livestock Superintendent.
27. No one at any time is allowed to ride or sit on any animal in all barns (including in stalls).
28. No horses are allowed to be turned out unattended in riding arena or exercise arena at any time.
29. All riders must wear heeled boots, long pants and a sleeved shirt. All 4-H registered riders are also required to wear an approved helmet at all times on fair grounds.
30. Approved riding times will be posted and followed, failure to do so will result in removal from the fair grounds.
31. No horses or other livestock are allowed on restricted paved or grassy areas.
32. All stalls, cages and surrounding areas must be maintained daily this includes but is not limited to: clean hay and/or shavings, water and food. All animals should be cared for before open barn time which is 8 am and as necessary.
33. 4-Hers may exhibit the same animal in open class only if they receive a blue ribbon in 4-H judging.
34. Horses being rode in the 4-H show are not eligible for equine open class.
35. All buck (male) rabbits need to be placed in bottom cages or boarded on all sides.
36. One stall and/or cage of shavings will be provided, additional shavings will be available for purchase.

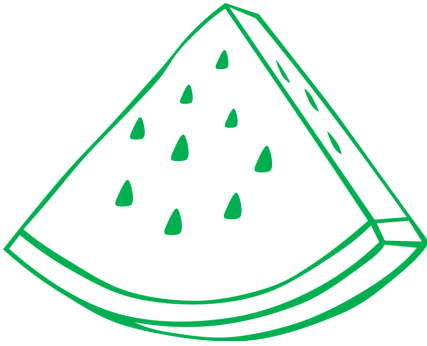

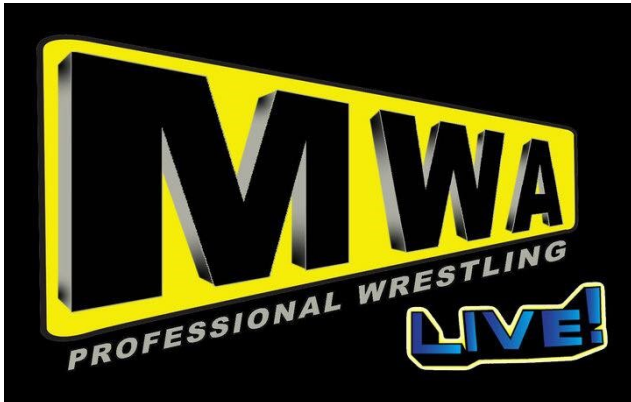

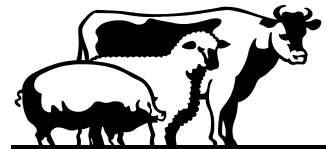
