# Town of Dix Regular Board Meeting February 19, 2024

Supervisor Smith called the regular meeting to order at 6:30 pm followed by the Pledge of Allegiance.

## Public be heard

Patty Eisenhart – Meads Hill Road project, prospective owners should be able to afford their own water. Another issue - the speed limit on County Road 17 is 45 mph from CR 16 to Wedgewood, but the speed limit on Wedgewood 55 mph. Supervisor Smith responded that a request was brought forward to have all of County Road 17 reduced to 45 mph but the State rejected the section from State Route 409 to County Road 16. We can forward another request for Wedgewood Road again. She also asked if the water is tested? Supervisor responded that yes it is tested daily and a report is sent to Board of Health monthly. She also asked how long water meters are good for and should they be changed. Supervisor responded that they should last 20-25 years. Some have been in 18 years and some less. She asked why the yield sign at the intersection of Meads Hill and Wedgewood was changed to stop sign. Supervisor Smith stated that was done before he was on the board and did not know why.

Elaine Dalrymple – would like the board to request a 90 day extension from DEC to allow more response time for the Padua expansion project. Geology needs to be looked at. Supervisor responded that there will be more discussion later.

Scott Burnside – added to Ms. Eisenhart's thought regarding the speed limits and reiterated the Supervisors response that requests go from the Town to the County and the County petitions State and then a study is done. The Supervisor will talk to the Highway Superintendent and start the process. It will probably be six to eight months before we hear anything. Mr. Burnside asked if the SEQRA for the Meads Hill project will include noise and traffic study. Supervisor Smith responded that yes it will and many other issues also.

Steve Yancey – thanked the board for being on top of what is going on and interacting with the public regarding the Meads Hill Road project. He has been frustrated and disappointed on how that came about and the response from other entities.

Tom Laughlin – he is afraid of rural gentrification; an elitist group is coming in and the indigenous people will be pushed out.

Bonnie Laughlin – how are they already advertising sales of these? Supervisor responded, they are not buying a lot, just a spot on a list.
