To the Sherburn and Welcome City Councils,

The department logged 133 calls for service for the month of May. This brought our total for the year to 825. For the same reporting period, we stood at 910 in 2014 and 645 in 2013.

Response time average for the month was approximately two minutes and fifty seconds. This time falls within our normal response time average.

The department is again going through personnel changes. Officer Nelson, who replaced Officer Keithahn one year ago this month, will be leaving June 19th for a position with the Northfield Police Department. Officer Nelson served the department well and had recently joined the ERU team as well. We thank him for his service to our communities and he will be missed. We will begin the hiring process to replace Officer Nelson within the next few months.

We are also anticipating some part-time officers leaving the department in the near future for full-time positions elsewhere, so our first task is to fill these part-time positions. Part-time officers fill an important role for us since they are utilized to fill open shifts as they come up.
