Dear Judge Waugh:

As you are aware, this office represents Suzanne Mathews in the above-referenced matter. In view of the case management conference that Your Honor has scheduled for Monday, December 19, 2005, we felt it necessary to inform the Court of several issues that will affect scheduling in this matter.

Trial was supposed to begin on December 5, 2005, before Judge Spencer in the Texas court. However, on the eve of trial, and in a blatant attempt at further forum shopping due to adverse rulings in the Texas state court, Mark Glasser filed a Notice of Petition for Removal of the action to federal court. See Notice of Petition for Removal, attached hereto as Exhibit A. In an effort to advance the proceedings, Ms. Mathews filed a Motion to Remand to the Texas state court so that the matter could proceed before Judge Spencer, who has presided over the case from the beginning. At present, those motions are pending before the United States District Court for the Western District of Texas, San Antonio Division.

In yet another attempt to circumvent the rulings of the Texas state court, Mark Glasser contacted the Texas Department of Family and Protective Services, Adult Protective Services Division, alleging physical abuse and exploitation by Ms. Mathews and her husband, Gilbert Mathews, against Mrs. Glasser. However, in a significant development, that agency has closed its investigation, finding the allegations to be "invalid." See Letter from Debra Wanser, Assistant Commissioner for Adult Protective Services, dated November 22, 2005, attached hereto as Exhibit B.

Unfortunately, it has become readily apparent that the impetus behind this case is not the best interests of Mrs. Glasser, but rather Mark Glasser's "wishes" as evidenced by the December 12, 2005 letter from his attorney to Ms. Mathews' Texas counsel. See Letter from R. Jo Reser, dated December 12, 2005, attached hereto as Exhibit C. This is a pre-death will contest.

Based on the foregoing, and as set forth in our Motion in Lieu of Answer filed on October 5, 2005, we respectfully request that the Court stay the New Jersey proceedings pending
