Fouts moved and was seconded by Humke to approve Jasper Construction's quote to patch Emerson Hough for \$1,519.00. Motion carried 4-0. Norman will contact the school regarding the remaining quote from Jasper Construction for storm sewer and road repairs on Thomas Jefferson. Norman also reported that he has cleaned off drains again.
