Trustee Ellinger reported for the month. There was a resident that asked about a permit. Trustee Ellinger received a call about a camper trailer on Jacobs Ladder Road that a family was living in it. Landmark called about them moving tanks.

REGIONAL PLANNING REPORT:

They started up a comprehensive land use plan committee for Fairfield County, which includes MORPS. First meeting was January 18, 2017 at 2:00pm.

CORRESPONDENCE FROM THE FISCAL OFFICER:

Minutes from the January Special Meeting being read prior by the Board were approved s read, so moved by Trustee Ellinger and seconded by Trustee Wolfe. All were in favor with 3 ayes and no negative votes, motion passed. Fiscal Officer is working on year end reports and paperwork. Fiscal Officer received an email about a resident asking about internet possibilities and if the Trustees could assist. There was discussion held and will be looked into. Trustee Gail Ellinger motioned for Hocking Township to place a 50% road weight limit on all roads and streets within

the Windy Hills Subdivision, Stonewall Cemetery Road from Snoke Road Intersection to the dead end, both sides of Country Club Roads (North and South), and Mill Road for CY2017. This will become effective February 2, 2017. Motion was seconded by Trustee Tim Wolfe. Trustee Gail Ellinger motioned to transfer \$30,000 from the General Revenue Fund to the Special Levy – Fire and Emergency Fund to pay for expenditures. Motion was seconded by Trustee Tim Wolfe. Roll call vote Ellinger – Yes, Claypool – Yes, Wolfe – Yes. Motion approved.

FIRE DEPARTMENT:

Fire Chief Golden reported we have begun the 24 hour schedule and is working good. Total runs for the month were 66.

OLD BUSINESS:

AEP with whom we have a RUMA with will be repairing the road this year.

Mr. Pat Marshall of Country Club Road is getting gas lines to his home and then onto lots that will be sold off. The Township has not heard back from Nate Wagner for setting up a RUMA.

NEW BUSINESS:

The ODA will be holding a public meeting at the township building on February 2, 2017 from 6:00pm – 8:00pm to answer questions about the spraying or trapping program this year for the aerial treatment.

Trustee Wolfe moved to pay the warrants for the month seconded by Trustee Ellinger. Roll call vote Ellinger – Yes, Claypool – Yes, Wolfe – Yes. Motion approved.
