CONSTRUCTION UPDATE

Construction that was scheduled last year from September 2017-January 2018 was cancelled due to two Hurricanes that hit our coast in the months of September and November.

We have tentative plans to continue the second phase of the window project this September 2018-January 2019.

The second phase consists of finishing the additional sliding glass doors in all oceanfront C & D units and 8B & 8C. In these 8B & 8C units, the back bedroom (3rd bedroom) will have a barrier wall to block dust and debris from getting into the unit; this will leave the unit feeling very dark, but still usable. On floors 2 -7 C & D, the middle bedroom will have a barrier wall installed.

The windows on the 1st floor will also be replaced with hurricane wind resistant windows.

There may be drilling noise heard throughout the whole building, but only during working hours of 8am-5pm Monday-Friday.

2018 IN-HOUSE EXCHANGE PROGRAM



The resort has opened an opportunity for owners to exchange their unit owned weeks for another week within the resort based on availability, which is limited. The in-house exchange fee is \$49, and the policy requirements are as followed.

- Owners will have to choose their week as soon as they call to put their unit up for deposit.
- Owners may only exchange their week 30 days prior to their unit/week arrival date.
- Owners must be current on their maintenance fees.
- Owners may only choose units that are the same size as what they own and within the current year of deposit.

IMPROVEMENTS GOING ON

We always take in account the many suggestions and comments that we get from our owners and guests in hopes to fulfill everyone's needs. Using this input, Management, along with the Board of Directors and Staff, have been working hard and making great strides in upgrading the building while improving the overall building life. Please make sure you take some time to fill out our suggestion & comment sheet either during your stay or online on our website. Here is a list of things that have been going on this past year.

- The sofa sleeper and loveseats have been replaced in the A/C/D/F units on the 2nd 7th floors, as well as all the units on the 8th floor. The sofa sleepers and loveseats are made for commercial use, they can withstand a lot more use and sleep more comfortably "no more bar in your back!" These sleepers are made with Leggett & Platt mechanisms, a solid oak frame, attached rear cushions with solid core foam. They provide more support and come with a 6-inch mattress.
- Some of the outdoor lounge chairs have been replaced.
- Some TVs have already been replaced with larger sized TVs in the Living rooms and bedrooms as units become available.
- Some lighting is being improved in units along with ceiling fans in some of our B & E
 units as units become available.
- Painting of common areas and in units as needed.
- NEW ADDITION to the building is our GIFT SHOP! Items that are currently available are towels, t-shirts, tote bags, snacks, soda, ice, personal items, sunblock and swimmer pants for the little swimmers of Marine Terrace.

PARKING

Parking is limited! The resort offers <u>one</u> parking spot for each unit in the garage. However, the garage clearance is 6′ 9″, so in the event that your vehicle doesn't fit in the basement, you will need to park upfront. It will be subject to a first come, first serve basis as there is only twelve spots and we cannot reserve or hold parking spots. All vehicles must be registered to avoid towing at owner's expense. No trailers, boats, mobile homes or RV's and the like are allowed on the property.

NO SMOKING ALLOWED

Marine Terrace is a non-smoking resort. No smoking is allowed on the property, except in the designated smoking area outside only.

NO PETS ALLOWED

Pets are not permitted on our property except for Service Animals as governed by the American with Disabilities Act (ADA). Service animals must be under the control of the owner at all times. This means they should be on a leash and cannot be left in the unit alone and unattended. If you have a Service Animal, you must register your Animal prior to arrival at least one week in advance.
