#### COUNCIL MEETING

## **JANUARY 5, 2017**

Meeting was called to order by Mayor Patrick Edwards at 6:59 p.m. Roll call: Tom Clark, Cindy Humke, Kent DeGoey, Steve Thomassen and Cathi Fouts present. DeGoey moved and was seconded by Fouts to approve the agenda. Motion carried 5-0.

### **New Business:**

- a. Kristie Wildung who works for the Central Iowa Water Association and the Utility Management of Central Iowa was in attendance to discuss the status of the sewer project. DeGoey updated Wildung stating that there has been a new manhole put in place and from that manhole to the creek has new pipe with sewage running through the new pipe. The contractor has yet to cross the creek and then set a new manhole. Wildung is uncomfortable with the progress as is the Council and she will reach out to the contractor to see how we can get the project done. DeGoey also informed Wildung that there is a 238' section of pipe yet to be lined. SAK is not able to line it, but JP Drain Cleaning & Plumbing may be able to do so. Clark moved and was seconded by Humke to have JP Drain Cleaning & Plumbing camera the 238' section of pipe that still needs to be lined. Motion carried 5-0.
- b. Approval of the Attorney Employment Agreement was tabled until next month as the agreement sent by the attorney's office had the wrong city's name in the agreement.
- c. The City Clerk will prepare a 2018 budget rough draft for review at the next meeting.
