ZONING INSPECTOR

Wayne Sarna reported:

Issued permit for new home - single family, 9686 Western Reserve Road, flag lot, \$1,364 fee.

Issued permit for privacy fence - 4680 S. Bailey Road, \$25 fee.

Issued permit for sun room addition - 7340 Rolling Hills Drive, \$124 fee.

Received complaint regarding water being diverted due to construction of a new home at 7920 Knauf Road. Wayne contacted the County and was told this is a neighbor dispute. He discussed the problem with the builder and builder agreed to extend drains and possibly put in a swale.

Foreclosure complaint against 6336 Elk Road was dismissed because property owner paid back taxes. The garage and trailer that are still on the property are dilapidated and the property is not maintained. Wayne sent the owner a letter advising them to remove the garage and trailer.

Tall grass is a problem at a property on Palmyra. The owner is in a nursing home and an attorney is in charge. Wayne will discuss with Trustees.

OLD BUSINESS

Dee Tripp reported that the Trustees approved the revised fee scheduled that the Zoning Commission recommended with one change. That change added "Plats" to - PUD's and Plats will be charged \$100 per building lot area or a minimum of \$1500 flat fee.
