Public Comments: Greenwood resident, Carter Belford inquired if there was a drug problem in Greenwood or why the need of a K-9. Chief Gibson replied that all areas have their share of drug issues and that Greenwood wants to be proactive.

Alderman Edwardes- indicated that he felt the information that was given on the K-9 unit was not completely a full picture of the costs involved and seem to contradict the initial projections. Alderman Newsom then requested that the Town Clerk do a cost analysis from the prior years of K-9 expenses.

Alderman Robinson requested that Glen Mazier either add his Property Standard cases to the report which is currently presented to the Board or he have a separate report of his cases. Town Clerk, Veronica Brown advised that starting in March he will comply with the request.
