Rules

- 1. Facility hours are from 8:00am to 7:00pm. If additional time is needed please seek permission by the Management.
- 2. Cigarette, Cigar and Pipe smoking are prohibited on Stable grounds.
- 3. ASTM/SEI Hard Hats are required at all times when mounted.
- 4. Children under the age of 12 must be accompanied by an adult at all times.
- 5. No horse is to be left unattended while tied.
- 6. Do not block any door or isle way for any reason.
- 7. Owners, Farriers, Riders and Veterinarians must clean up after themselves and dispose of manure in designated area.
- 8. Owners, Riders, Farriers, Veterinarians and any other scheduled or non-scheduled event must respect the JRF Horse Training Board and Training schedule according to JRF Equestrian's Google Calendar. All visitations and appointments must not be scheduled during lessons, trainings, camps, workshops and all other JRF Events. Riders are allowed to ride their horse during these events as long as the safety of the horses and riders are not at risk.
- 9. All unnecessary discipline of any kind to a horse such as abuse, gross neglect, or injury by drug intake is prohibited.
- 10. All guests and or relatives are required to follow all rules and regulations set forth by this establishment. Failure to do so will result in being asked to leave premises.
- 11. All guests are required to sign a Liability Waiver when riding and/or handling equines.
- 12. Payments are due on or before the fist of the month. If payments are received after the fifth of the month, a late fee of \$35 will be applied to your account.
- 13. Any returned checks by the financial institution will result in a \$35 fee applied to your account.
- 14. Do not handle, ride, or use any horse or property that does not belong to you without permission by the appropriate owner.
- 15. Be respectful of others, animals, and yourself. "Slander" and/or "Stealing" or any act related of any kind will result in a verbal warning upon first offense then immediate termination upon second offense.
- 16. Proper Horsemanship and care is required at all times when handling or riding your or other horses.
- 17. All Dogs or outside animals must be on a leash or humanly confined for the safety of others and the animal.
- 18. Any and all concerns and requests must be addressed with the Management.
- 19. No fishing.
- 20. Respect the privacy of all people, families, guests, animals, housing, lawns, vegetation, bees and hives.

Your cooperation in following these rules as well as adhering to them is greatly appreciated. It is your responsibility to inform all guests of these Rules and notify appropriate persons if any of these rules are not followed.
