



**Proceedings:** *Meeting called to order* at 6:38 p.m. by Steve Kiluk. · Steve led the pledge of allegiance. March meeting minutes were approved.

- 1. Financial report update from Mark Hodorek. The city council is considering voting for donated 3,000 to the committee. The balance as of 3/17/2015: \$11,148.07
- 2. Peter McInnes distributed badges.
- 3. Rain barrel update- Steve Kiluk. There are 22 rain barrels remaining in storage and one on display at Lakeview HS. Mark will set up rain barrels in the other two high schools. There was discussion to distribute rain barrels to schools outside of SCS in an effort to educate students on the green initiative. Mark wants a rain barrel displayed at the nautical coast clean up.
- 4. Erin Stahl wants to produce and pass out door hangers before the clean-up. The cost of the door hangers in 2014 was \$318.00. Erin will have estimate for this year printing cost of door hangers at the next meeting.
- \*Motion from Mark Balon: To approve \$400.00 printing cost to spend on 5,000 door hangers for the nautical coast clean up. Motion carried. Erin will go forward and have door hangers printed up for distribution before the cleanup in May.

Freeway cleanup starts on May 9; 2nd Saturday of the month.

5. Christian reported on the kayak/canoe project. He will be applying for the IBM grant which supports the project when it opens in April.

He will also talk with Margie on the bag project which is scheduled for distribution at the SCS Memorial parade.

6. Lake Cleanup: Christian also suggested no front loader at the beach on cleanup day because it delays the volunteers from getting started.

Mark Hodorek suggests the music/DJ selection be targeted to the students.

- 7. \*Motion from Mark Balon: To excuse members not in attendance. (Kevin Hertel) Motion carried by all.
- 8. Eric reported that he is building a new website for the committee.
- 9. Discussed to increase the size of the committee with 2 additional alternate positions. Alternate positions would have to be approved by sub committees. Mark recommended connecting by ipod or other such media to allow for conference calls for members that cannot attend the monthly meetings since conference calls allowed for some if needed by City standards for committee.
- 10. The committee discussed other content of letter from the city in regards to being in compliance with the rules of conducting meetings.
- **11.\*Motion** from Mark Balon to order 120 shirts for the cleanup with the saying "No Dumping –Drains to Lake" with the Fish picture on it. Motion seconded by Mark Hodorek. 8 approve 1 oppose

The shirts will be purchased at a cost not to exceed \$600.00. Dave Rubello to follow up on the ordering of the shirts.

- 1. Meeting called to order at 6:30 p.m. by Mark Balon. Mark read the group's mission statement and led the pledge of allegiance. Jill recited words of encouragement.
- 2. March, 2015 monthly meeting minutes were approved.
- 3. Griffin Salk is now an Eagle Scout and reported on his project with wren houses. He has built 11 houses and plans to construct a minimum of 20 altogether. These are to be placed in residential backyards. 14 will be placed in the Harper Woods and St. Clair Shores area. He plans to place 6 at the Gilbert's Sportsman Club at 26 Mile and Omo Road. Boy Scout Troop 273 plans to monitor the houses at the 26 Mile location. Griffin has kept detailed records and taken pictures of the project, which he will bring to our next meeting. Michael Tances, Jr., Scout Leader for Boy Scout Troop 273 is also in attendance. As to the construction of the houses, the clean out is on the bottom, and the side swings open so that the inside of the boxes can be viewed. If any of the committee members would like a wren house to place on their property, they should advise Griffin. Griffin will present this project at the 2016 annual meeting.
- 4. No financial report. However, Peter Rubino indicates that the \$3,000 donation from city council has not yet been approved and will be voted on at the end of June, 2015.
- 5. The Rain Barrel Project was discussed. Mark B. reported on 2 rain barrels constructed at Ardmore School and distributed photos of the project. Mark B. also reported that the schools would like additional rain barrels. Motion for allocation of \$400 to install 4 additional rain barrels at schools (Rain barrels are \$55 apiece; extra material to install is approx. \$45); (M. Balon 1<sup>st</sup>; P. McInnes 2<sup>nd</sup> Passed). Stephen K. will report at next meeting as to additional work of putting additional materials on rain barrels stored by the City. In order to obtain a rain barrel, you pay \$55 at City Hall and then take receipt to DPW to get barrel.
- 6. 20<sup>th</sup> Annual Nautical Coast Clean-Up May 17, 2015. Jill Wrubel has been arranging for donations of sign and food items. Jill obtained 3 bids for T-shirts. PIP Printing will print signs and T-shirts. Donated food items will be obtained from The Wine Dock, Mikes Waterfront, Fishbones, Bryan Mazey, Ninos. Jill is still waiting to

hear back from Detroit Coney Island, Rams Horn, Eastside Bagel and Costco. Food items will include hot dogs, chicken, subs. Tom Cleaver and the We Are Here Foundation annual contribute \$2,000.00 toward costs of the Nautical Coast Clean-Up. 24 Trash Captain Shirts will be printed (8 Medium, 8 Large, 8 XL). 200 volunteers shirts will be produced (100 Medium; 100 Large). The committee voted to have white T-shirts as they are the cheapest to produce; (M. Balon 1<sup>st</sup>; P. McInnes 2<sup>nd</sup> – Passed). Jill also indicated that in the future we should consider order pins and visors for cleanup. Dave Rubello will be getting prices for the DJ. Joe spoke to Brent Avery. There will be one front-end loader for the Blossom Heath location. Ron Dempske will be contacted to have 1 or 2 loaders for Veterans Memorial Park. Ron will attend our next meeting prior to the clean-up. Peter Rubino indicated that the front end loaders should do their job prior to the volunteers being on site and it is important for them to confirm this. Divers and tow truck are in place. There will be a walk through prior to the clean-up. Joe will take care of press release. Joe indicated that banners have been put up at Veterans, JYC, Island Harbor Marina, Civic Arena, the Dive Shop, the fence on Jefferson and there is one more in very good condition to use for presentation at the City Council Meeting. Peter Rubino will make sure this event is on the May 5th City Council Agenda at the beginning of the meeting. Christian, Erin, Heidi & Peter plan to attend. All committee members are encouraged to attend and bring rake, bucket, gloves. Joe got 2 permits, one to hold the event and one for putting up the banners. Joe will take the banners down after the event. If anyone sees banners that are not positioned correctly, either fix the problem or advise Joe and he will fix. Jill had 3,000 fliers printed. Eric had 5,000 door hangers printed. These materials can be distributed beyond SCS borders (Eastpointe, Grosse Pointe, etc.). For future reference, Ken Kmieske needs to be advised of the clean-up date and meetings well in advance so that JYC can reserve the location.
