RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND

INDEMNITY AGREEMENT ("AGREEMENT")

I hereby release, discharge, and covenant not to sue **BELIZE JUNGLE ATV ADVENTURES LIMITED**, its Respective administrators, directors, agents, officers, volunteers, and employees, other participants, any sponsors, advertisers, resort/hotel providing activity and if applicable, owners and lessors of premises on which the Activity takes place, (each considered one of the "RELEASES" herein) from all liability, claims, demands, losses, or damages on my account caused or alleged to be caused in whole or in part by the negligence or the "Releases" or otherwise, including negligent rescue operations; and I further agree that if, despite the release, waiver of liability, and assumption of risk I, or anyone on my behalf, makes a claim against any of the Releases, I will indemnify, save and hold harmless each of the releases from any loss, liability, damage, or cost which any may incur as the result of such claim
