NORTH TEXAS GROUNDWATER CONSERVATION DISTRICT NOTICE OF PUBLIC MEETING TO ADOPT DESIRED FUTURE CONDITIONS December 13, 2022

NOTICE IS HEREBY GIVEN to all interested persons in Collin, Cooke and Denton Counties, Texas:

That the Board of Directors of the North Texas Groundwater Conservation District ("District") will hold a public meeting, accept public comment, and consider adoption of the Desired Future Conditions for the groundwater resources within the District pursuant to Section 36.108(d-4) of the Texas Water Code. The District is required by Section 36.108 of the Texas Water Code to adopt Desired Future Conditions for the groundwater resources within its boundaries. The Desired Future Conditions for the District-wide average aquifer drawdown through 2080 of (in feet by aquifer/layer): 263 in Woodbine; 690 in Paluxy; 366 in Glen Rose; 601 in Twin Mountain; 305 in Antlers. County-wide average aquifer drawdown through 2080 of (in feet by aquifer/layer): Collin County - 482 in Woodbine, 729 in Paluxy, 366 in Glen Rose, 560 in Twin Mountain, 596 in Antlers; Cooke County - 2 in Woodbine, 191 in Antlers; Denton County - 22 in Woodbine, 558 in Paluxy, 367 in Glen Rose, 752 in Twin Mountain, 416 in Antlers.

The District developed the Desired Future Conditions as required by Chapter 36 of the Texas Water Code with the other groundwater conservation districts in Groundwater Management Area 8. The other districts within Groundwater Management Area 8 include: Central Texas Groundwater Conservation District; Clearwater Underground Water Conservation District; Middle Trinity Groundwater Conservation District; Northern Trinity Groundwater Conservation District; Post Oak Savannah Groundwater Conservation District; Saratoga Underground Water Conservation District; Southern Trinity Groundwater Conservation District; and Upper Trinity Groundwater Conservation District.

The public meeting will be held on Tuesday, December 13, 2022, at 10:00 a.m. at the District's board meeting location at the Pilot Point ISD Administration Office, 829 S. Harrison Street, Pilot Point, Texas 76258. Comments on the Desired Future Conditions may be presented in written or verbal form at the hearing, and persons interested in submitting written comments in advance may do so by email at ntgcd@northtexasgcd.org, by mail at P.O. Box 508, Gainesville, TX 76241, or by hand-delivery at 5100 Airport Drive, Denison, TX 75020.

The District Board of Directors will also hold a regular Board meeting at the same time and place as the public meeting on the Desired Future Conditions. Agenda items for the regular Board meeting include: Call to order, establish quorum, and declare meeting open to public, public comment, approval of minutes, review and approval of monthly invoices, receive monthly financial information, update and possible action on process for the development of Desired Future Conditions, consider and act on compliance and enforcement activities for violation of District Rules, General Manager's report (update on operational, educational, and other activities of District), open forum/discussion of new business for future meeting agendas, and adjourn meeting.
