- 1. The meeting was called to order at 6:32 p.m. with a quorum established.
- 2. The agenda was reviewed and approved.
- 3. The minutes of the strata council meeting held November 7, 2022, were reviewed and approved.

4. Financial report

- The financial statements up to the end of November were not available at the meeting; they will be distributed as soon as possible afterwards.
- Maturing GICs (about \$200,000) for the contingency fund have been renewed for 100 days at 3.15% interest.
- We have been notified of a 7% increase in garbage tipping fees for 2023 from Metro Vancouver.

5. Gardening

- We'll be asking the landscaper for a proposal for replacing plants and shrubs in the spring.
- There has not been a quote yet for any COL increases in our landscaping contract.

6. Maintenance

- The quote for parkade cleaning was for \$2,600. This is yet to be scheduled.
- A drone inspection of the roof for further areas of exposed vents/leaks was postponed by the recent snowfall; this will be rescheduled.
- Bridgenet/Novus were also scheduled for installation, but also delayed due to snow.
- Thank you to volunteers who helped with snow shoveling.

7. Correspondence and bylaw infraction letters

Reminder – if you have a concern about a bylaw, maintenance issue, comments, etc., please send it in writing to <u>victoriahill@shaw.ca</u> with your name and unit number. You should receive a response in 48 hours.

• A request from SL36 was received to use the amenity room for some regular appointments on a weekday; this was approved.

8. Christmas party

• The annual holiday party will be held on Saturday, December 17; all are welcome. Notices will be put up, and we will provide refreshments/snacks (to be paid from refundable bottle fund.)

9. **AGM**

- After a discussion of dates, we will hold the next AGM for March 6, 2023, at 6:30 pm.
- BC strata regulations now allow for virtual AGMs and SGMs to be held; whether the meeting will be virtual or in person is TBD.
- The meeting package will need to be distributed in mid-February.

10. Other business

- We received 36 maintenance surveys back (out of 72 units). Dustin will tabulate the answers and report back on the results for the next meeting.
- BC passed amendments to the *Strata Property Act* in November such as removing the ability of stratas to restrict rentals and allowing electronic participation in official strata meetings. Mike will review these changes and summarize at the next council meeting.
- The next strata council meeting will be set for Monday, January 9, 2022.
