# **LIWMD Update Feb 2015**

#### Alligator Update

We have not had any reports of alligator sightings since mid-December. Our state-authorized trapper for 18 years resigned from the program late last year and the world-famous Gator-Boys from Holiday Park are now the authorized trappers in our area. We frequently see reports on "Next Door Lauderdale Isles," of alligator sightings. Often, the people who make these reports say they "didn't know who to call." The FWC Nuisance Alligator number is on this page and also the back page of this newsletter. Based on information from the alligator experts, we can expect the gator "Wiley" to return. Please call the FWC if you spot him.

#### Oil Spills

There have been quite a few oil spills in our canals and the river in December and January. The spills are almost always diesel fuel. The police will respond, if called. Occasionally, the Fire Department will respond as well, apparently because the dispatcher hears the words "fuel spill." If we are notified of them, LIWMD attempts to respond, too. Unless there is an eye witness to point out a specific boat causing the problem, these cases are difficult to solve. But if you do see a spill, call it in. It is only a matter of time until one of these violators is caught and the police will not treat the case lightly. It's not a bad idea to check your own boat's bilges frequently, too.

#### March MIASF Waterway Cleanup

The 38<sup>th</sup> Annual MIASF Waterway Cleanup is March 7<sup>th</sup>, at the yacht club. LIWMD is the site sponsor and will be providing boater's gift bags, as well as prizes for the most unique items brought in. These Waterway Cleanups are great neighborhood events and lots of fun, even if you don't have a boat, so come on out and lend a hand.

# **Dilapidated Docks**

The City Code Enforcement and Building Departments sent inspectors out in an FLPD Marine Unit boat in late September and cited (20) docks throughout the Isles. As of late January, the online Code Enforcement system indicates: (9) cases closed, (7) cases open & (4) scheduled for hearings before the Special Magistrate.

#### Canal Dredging Update: GREAT NEWS!!

The long-awaited canal dredging project for Lauderdale Isles officially started on Jan 12<sup>th</sup>, and should be completed by the end of April, barring any unforeseen delays.

According to surveys conducted by the City, 2620 cubic yards of material will be dredged from nine canals (the Cobia Canal does not require any dredging).

We have posted a lot of information on the LIWMD website about the project, including drawings of each canal indicating where dredging is required. Additionally, we will update that website every 7-10 days with the latest info as we receive it from the City's Project Manager and the dredging contractor, Gator Dredging. Go to: www.liwmd.org

#### Dead Manatee at Boat Ramp

Unfortunately, the FWC discovered a dead 7 foot female manatee in the Marina Mile stretch of the New River on Tuesday, Jan 13. It was towed to the Riverland Woods Park boat ramp and tied to the dock to await examination by a biologist on Wednesday. It was found to be too decomposed to determine cause of death, and was removed from the water that day.





# AT LAST - THE DREDGING PROJECT IS UNDER WAY!

After many years of LIWMD working with the City of Fort Lauderdale Public Works Department, our long-awaited canal dredging project is a reality. The contractor for the project, Gator Dredging, started work on January 12th. The project should be completed in April.

There were some minor snafus the first week: a dead manatee at the boat ramp, an unknown underwater cable that had to be investigated, and re-design of the unloading area by the boat ramp was necessary. Work then progressed smoothly on the Sailfish Canal, except for Monday, Jan 26th, when an oversize boat that had been docked by a neighbor over the weekend blocked access to the canal for a day.

The City Public Information Office mailed out a flyer to the entire neighborhood announcing the start of the project. A second flyer is supposed to be delivered to neighbors approximately one week before the dredging starts on a specific canal.

There you will find all kinds of detailed info regarding all the aspects of the project. The website is updated every 7-10 days.

NOTE: The contractor has determined that there are several homes throughout our canals where large boats will need to be moved in order for the dredge to maneuver down the canal. The City has told us that those homeowners will be given 30 days notice to move those boats. That info will be posted on the website when we receive it from the city.

This dredging project is considered "maintenance dredging," & its purpose is to maintain the center 20 feet of the canal for navigation. The area by your dock will not be dredged. The city's engineering drawings specify where dredging will occur & the contractor follows those drawings.

When you see the barge coming down your canal, give Anthony and Kevin, the dredge crew, a friendly Lauderdale Isles "Welcome!"

# **HOMELESS ACTIVITY REPORT**

In case you didn't read my last article about the homeless and vagrant issues in Riverland, allow me to briefly summarize what we faced in 2014.

Our neighborhood has seen homeless and vagrant activity, especially near our parks and the convenience stores at the end of old Riverland Road and 441. The root of the problem is from a homeless encampment located on the New River underneath the SR7 bridges, and the Turnpike on-ramp. In addition, the convenience stores have been very welcoming to the cigarette and beer buying habits of the homeless crowd.

If you are unfamiliar with homeless issues, the vast majority are what is called, "dual diagnosis". That means they have mental instability and psychological issues in addition to substance addiction. There are also a number of sexual predators and offenders that call the SR7 bridge their official address. These individuals have exhibited volatile and aggressive behavior in our parks and streets. Since April, I have been trying to resolve the problem to make our parks and neighborhood safer. Keep in mind, homelessness is not a crime. So this has been a challenging project to make our neighborhood less attractive to homeless individuals.

I have been working with the Department of Transportation to block access to the shelter provided by the bridges. In early January, most of the access points had been blocked by fencing and razor wire. There are still some outstanding issues as far as the fencing. The barrier over the sea walls at Riverland Woods Park and at Broad Park continue to be vandalized. I suspect a few individuals are still living under the bridge based on the bedding, clothing, and other supplies that are under the 3 bridges. During December, the barrier project was put on hold because a "right of way" needed to be obtained from South Florida Water Management District. The right of way still needs to be approved, but apparently they allowed work on the barrier project to continue. A big thanks goes to Geoff Rames for helping me monitor the situation.

In addition to barriers, we have also been working with law enforcement to continue to discourage the homeless from making our neighborhood their home. Dirk Lowry has been working with Town of Davie Police (responsible for the area under the bridges) and Fort Lauderdale Police (responsible for Riverland Woods Park) to keep vigilant about managing the illegal activities of the homeless and work with homeless services to provide housing options. I'd also like to thank Dirk for his

insight and expertise in law enforcement. He has been an effective liaison between our neighborhood needs and the various law enforcement agencies involved.

Keeping the homeless and vagrants out of Riverland will apparently be an ongoing project. We will need to be vigilant to ensure that we don't allow the homeless encampment to grow to the 2 dozen beer drinking, bonfire-lighting individuals we had to deal with over the summer of 2014. Although we are making significant progress, follow through and monitoring will be required to keep our community safe.



# Thinking of taking a boat ride and stopping for lunch?

You may want to try these restaurants...

There are numerous restaurants from the Lauderdale Isles area that are easily accessible by boat and always a fun ride without traveling a huge distance. We generally try not to venture out for lunch on the weekends since the docking space is even more limited and boat traffic and restaurant crowds can be huge. Some of our favorite spots that we tend to frequent include The Rendezvous, Bokampers, Coconuts, Bahia Mar and Shooters. There are numerous others along the New River and Intercoastal waterways, but docking sometimes can be quite challenging.

The Rendezvous on Marina Mile is close to Lauderdale Isles but dock space is at a minimum there. It is said to be a well kept secret in the Southwest end of town and caters to a large local crowd. Appetizers are excellent and there is a nice dining area overlooking the water and marina. We especially liked the bacon wrapped sea scallops, meat balls, quesadillas and calamari. Pets are not allowed.

Coconuts is probably our favorite spot for lunch, but again, dock space is minimal and you need to arrive fairly early to get a spot at the small dock, so we generally go by car rather than boat. Food is excellent and the crab scoobies are a favorite with everyone. My personal favorite is the Coconuts house salad with toasted shredded coconut, artichoke hearts and a fabulous dressing. Their signature coconut shrimp are also crispy and large and the daily specials are extensive. Wait staff is always personable and accommodating and their t-shirts say it all, "Be Nice"! They are pet friendly and always offer a cold dish of water for your furry friends. There are also huge amber jacks

and tarpon swimming around the dock area for added entertainment.

**Bokampers Sports Bar** is definitely a haven for the sports fan, but equally inviting to everyone. Over 100 large screen TV's grace the walls to view every sports event or TV show available and there is ample dock space for several boats. If you prefer to go by car there is also plenty of parking. Food is good and the menu is probably one of the most extensive I've seen anywhere, almost a bit overwhelming and sometimes difficult to make a choice, as everything sounds incredible. They are also very pet friendly.

**Bahia Mar** offers a beautiful view of the marina and water traffic and food/service is ok but, in my opinion, not great. They are not pet friendly and we always bring our little dog with us on our boating excursions so we tend to gravitate towards Coconuts or Bokampers where they welcome pets. The restaurant needs updating and wood bench seating is quite uncomfortable if you want to sit and linger over your lunch.

Further up the Intercoastal and just before the Oakland Park bridge is **Shooters**, a Fort Lauderdale institution, which has recently undergone a huge renovation and refurbishing. It is quite inviting for boaters and provides 340 feet of dock space and spectacular views of the Intercoastal water activity. Shooters is a step above your typical sandwich shop or deli type restaurant. Good food and service in a beautiful setting.

**Fifteen Street Fisheries** is another good eatery choice, right before the 17th Street Bridge and also a great spot to fish watch, especially around 5 pm when they throw out their kitchen scraps!

For the Northerners who miss the New England chowders, belly clams, lobster rolls and the best onion rings "evah", try **Kelly's Landing** on Cordova Road across from Winn Dixie. You can't get there by boat but the ride is well worth the trip as the food is always excellent.


