**Please be advised that after April 13, 2019, a \$5 administrative fee will be charged per application. Our office accepts exact cash, money orders or checks made payable to MASC Austin Properties, Inc.**

**If you have your pool tags from the 2018 pool season, please return them to MASC Austin Properties, Inc. as they are recycled.**

As a reminder, each homeowner must be in good standing with the Association regarding collections as well as deed restriction violations. Each homeowner must also provide proof of address in the form of a driver’s license or current utility bill in order to obtain pool tags. If you are a tenant, currently leasing your home, you must provide a copy of your lease or a current utility bill in your name.

Each household member and guest must have a pool tag to enter the pool area (maximum of 6 pool tags allowed per household). The homeowner or tenant must accompany the guests at all times.
