**Patter Pets, Inc.: TERMS AND CONDITIONS**

Vendors agree to follow all terms and conditions noted below. Failure to follow may result in removal of vendor privileges, immediate cessation of operations and vacating the premises.

1. Acceptance of applications will be considered based on receipt at Patter Pets mailing address P.O. Box 9594 Columbia, SC 29290 or emailed to patterpets@bellsouth.net. Patter Pets reserves the right to place or relocate vendors according to a master plan. While it is our goal to accommodate a vendor's location request; cancellations by applicant based upon dissatisfaction of placement will subject the applicant to forfeiture of all booth fees.
2. The Dog and Pony Show is a family event. Diversity of vendor items/information is encouraged. However, nudity, indecency or conduct inappropriate for a mixed audience will not be allowed. Vendors shall **not** display, offer for view or sell any illegal or contraband items.
3. Set up times are from 10:00 a.m. to noon on March 18, 2018. Vendors will drop off items and immediately remove their vehicle. Tear down will start at 5:00pm and the premises must be vacated by 6:00pm.
4. Illegally parked vehicles will be towed.
5. Vendors are responsible for all sales taxes, licenses and insurance required by law.
6. Vendors/organizations shall not share or sublet or give their booth space to anyone else. Nonprofits may not allow their booths to be used by "for profit" vendors.
7. No vendor or organization shall sell or offer any items imprinted, emblazoned or marked with any or any combination of the words "Dog and Pony Show, Patter Pets, or it's logo" without express written permission of Patter Pets.
8. Noise, smoke or visual displays shall not interfere with neighboring vendors or with the enjoyment of the public at the show. Patter Pets reserves the right to determine whether a booth is causing interference and ask for removal of any special effects that is causing the interference.
9. If goods are for sale vendors must post prices in a legible manner and in a visible place.
10. Patter Pets accepts no responsibility for items lost due to theft or breakage.
11. Vendors are responsible for any damages caused to other vendors or the show.
12. All use of power must be handled by the designated Patter Pets volunteer responsible for plugging into the power source. Vendors that require electrical usage will have grounded extension cords and these will be covered in a way that they will not impose a trip hazard.
13. In case of bad weather, a Patter Pets designated volunteer will decide whether to continue or stop anything using electrical power in the building.
14. Vendor will not be allowed in the show until the event representative is on site.
15. **All vendors unloading at the assigned space will have 30 minutes to unload their vehicles and remove it off the event grounds.** Vehicles are not allowed in the building during the event or after the event until the public is safely removed.
16. Vendors must not block walkways with vehicles or trailers.
17. Concession that utilizes cooking or heating devices shall have a minimum of:
  - a) 1 40BC portable fire extinguisher
  - b) 1 K type portable fire extinguisherThe extinguishers must be "in date" with a current inspection tag and be accessible and mounted.
18. All tents must be weighted down with water barrels, sand barrels or sand bags at each corner; no staking of tents or cinder blocks. Vendor will be responsible for supplying the weights for their tent.
19. Generators are not allowed unless preapproval is obtained.
20. Deep fryers must be in an enclosed wagon or trailer. Grease and oil must be disposed of properly; not poured on the grounds or in drains.

Applicant understands that the purpose of the Patter Pets Dog and Pony show is a to provide for family fun while raising funds for Patter Pets and community awareness about pet ownership.



Vendor applicant understands that Patter Pets has no control over weather, acts of God, acts of terrorism, governmental interventions, or any other cause that may prevent and/or interrupt the Dog and Pony Show. All participants shall hold Patter Pets, its board members and the grounds host harmless of any losses that could arise because of such events.

The applicant agrees to defend, indemnify and hold harmless Patter Pets, its' board members, and the grounds host from any claim, demand, suit, loss, cost or expense, or any damage which may be asserted, claimed or recovered against or from Patter Pets, its' board members or grounds host by reason of any damages to property, personal injury, or bodily injury, including death, sustained by any person whomsoever and which damage, injury or death arises out of or is incident to or in any way connected with the Dog and Pony show or third parties.

I (we) agree to hold Patter Pets, Inc., their members, directors, governors, officers, agents and the owner and/or lessor of the premises and any provider of services that are necessary to hold the Patter Pets Dog and Pony Show (hereinafter "the event") and any employees or volunteers of the aforementioned parties, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage.

Additionally, I (we) hereby assume the sole responsibility for and agree to indemnify, defend and save the aforementioned parties harmless from any and all loss and expense (including legal fees and attorney fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting there from, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this event, however such, injuries, death or property damage may be caused, and whether or not the same may have been caused or may be alleged to have been caused by the negligence of the aforementioned parties or any of their employees, agents, or any other person.

Patter Pets reserves the right to amend these terms and conditions at any time it deems necessary. These terms and conditions are not complete unless all pages are initialed, and form signed and dated.
