- 1. The Consignor is the owner of all goods consigned to Stylish Abode Consignments, LLC. and has the legal right to enter into this Consignment Agreement.
- 2. Stylish Abode Consignments, LLC. retains the right to accept or decline any item for consignment and display items accepted at their sole discretion. *Please understand when we cannot accept an item*.
- 3. All items must be presented clean, complete and free of defects or damage. There will be a processing fee if we have to clean or do small repair to an item and it will be charged to your account.
- 4. Consignors must wait for our staff to perform a quality screening of their items and take back any items that we will not accept. Furniture items for sale need to be sent via e-mail or text for review before they are accepted. When bringing furniture please have someone help unload as we may not be able to assist.
- 5. Based on the information you provide Stylish Abode Consignments, LLC will determine the most appropriate price based on our knowledge of the market but will take your price into consideration if it is reasonable. Stylish Abode Consignments, LLC reserves the right to sell items below their original list price if item is not selling.
- 6. Stylish Abode Consignments. collects a fifty percent (50%) commission on all of the list price. Items not sold after 30 days will be discounted by 30%. Where an item is sold below the original list price, commission is calculated on the reduced list price. All goods are tagged with the sales floor price.
- 8. Stylish Abode Consignments, LLC does not telephone Consignors regarding their consignment account.
- 9. Stylish Abode Consignments, LLC does not mail checks. The Consignor is responsible for collecting funds due for items sold, at the store location where the items were consigned the 30th of each month. Checks for less than \$10 will not be issued but can be used towards store credit. Uncollected funds become the property of Stylish Abode Consignments, LLC if not collected by the end of the consignment period.
