
Until the next time or we see each other in person stay safe and check on your friends and members you have not heard from. A friendly call is all it takes to brighten up someone's day.

Culinary Corner

Peppermint Stick Pie

INGREDIENTS:

3 pints (1 & 1/2 quarts) peppermint ice cream
1 chocolate flavored crumb pie shell
1 - 12 oz. jar fudge ice cream topping.
Coarsely crushed candy cane or striped round peppermint candies (optional)

TO PREPARE:

- 1. In a chilled bowl stir ice cream until softened.
- 2. Spoon ice cream onto pie shell, spreading evenly. Return to freezer for at least 4 hours.
- 3. To serve, warm the fudge topping in the microwave oven according to directions on the jar. Let pie stand at room temperature for 5 minutes before slicing.

Served with warmed topping. If desired, sprinkle with crushed candies.
