Nominating Resolutions:

National President: NVP James Campbell - Branch 040

National Vice President: PRPEC Donald A. Hoover - Branch 024

Constitution and Bylaws Resolutions:

Art 2, Sect 202 (Composition of Association) Resolved Summary:

The FRA is an organization of all current and all former per-sonnel who have many years of honorable service in the United States Navy, Marine Corps, and Coast Guard, in-cluding the reserve components. It is composed of the national association and its subordinate branches chartered under and pursuant to its authority, in the manner hereinafter provided.

Art 3, Sect 301 (Eligibility for Membership)

Resolved Summary: Eligibility for membership in the FRA shall be for all personnel who have served or are now serving in the United States Navy, Marine Corps, or Coast Guard, including reserve components and regardless of length of service.

<u>Art 3. Sect 301(c) (Eligibility for Membership)</u> Resolved Summary: To read as follows: "Associate Member" is defined as a person not eligible for regular FRA membership who has served or now serving in an enlisted status in the United States Army, National Guard, Air Force, or Space Force, regardless of length of service, including reserve components, under honorable conditions.

<u>Article 8, Section 810(1) (National Committee of Budget and Finance)</u> Resolved Summary:

That Article 8, Section 810 (I), C&BL, FRA shall be amended by adding: "(1) National Committee on Budget, Finance and Audit." and be it further Resolved, That Article 8, Section 811 and other appropriate sections where it reads "National Committee of Budget and Finance" to be changed to "National Committee on Budget, Finance and Audit".

<u>Article 8, Section 811(a) (National Committee of Budget and Finance)</u> Resolved Summary:

That Article 8, Section 811(a), C&BL, FRA shall be amended by adding: "Section 811(a). This Committee shall consist of the Junior Past National President as chairman, and six members appointed by the National President for terms of three years, two members being replaced or reappointed each year by the incoming National President. Members shall serve until relieved or replaced only with the concurrence of the National Board of Directors."

Article 8, Section 820(a) (National Committee on Veterans Service) **Resolved Summary**

FRA shall be amended as: "Section 821. Duties of the National Commit-tee on Veterans Service. "Section 821(a). The Committee shall consist of the Director, National Service or designated FRA accredited National Representative as chairman, and eight members, one from each region. A member's term shall be for three years with a minimum of two members replaced or reappointed each year by the incoming National President.

<u>Standing Rule 9 (Americanism Essay Contest)</u> Resolved Summary:

That SR-9(b) (2) remove the word "My" and replace with the word "the" Whereas, it is recommended that SR-9(b) (4) should be changed from; "Why I am Proud to be an American" to "What it Means to be an Ameri-can Citizen". Resolve, that SR-9(b) (4) that the first phrase be removed in its entirety and replaced with the second phrase. Whereas, it is recom-mended that SR-9(c) (1) the National Committee on Americanism-Patriotism be presented the change on the themes set before them.

Standing Rule 9 (Americanism Essay Contest)

Resolved Summary: That Standing Rule 9, SR-9(d) C&BL, FRA is amended by adding; "(4) The essay theme title must appear on the essay as written (5) The essay shall be legibly written or typed on one page and one side of the paper", and be it further Resolved, That SR-9(d) numbers (5) and (6) be renumbered to (6) and (7) respectively.


1st Sergeant Richard G. Johnson USMC (Ret) November 22, 1931 - May 22, 2021
