Ashley Samuel had previously requested via email for information for a Little Free Library that would be placed on a property. Susan McKenna gave all the information she obtained from the Village of Sugar Grove. This would require a building permit and it was discussed as to the

amount that is involved with her great idea to be completed. She thanked the Board for the information and would investigate further.

Jeff Gengler asked the Board if anything can be done about the ongoing issue with Commercial Vehicles being parked in driveways. We acknowledged the issue but stated without more resources to take pictures during late nights, it was hard to enforce. The Board expressed agreement something should be done if possible.

William Kelly informed the Board about an incident with a dog. He gave a lengthy story about his encounter and his reporting it to the authorities. Susan stated the Village of Sugar Grove and the Kane County Animal control are his options, which according to his story he has contacted.
