

## Special Town Board Meeting with FCP Tribal Council

June 9, 2021

The meeting was called to order by Chairman Ned Daniels at 1:07 PM. Attending were: Jason Headson, Lynne Black, Tressa Votis, Board Members. Also in attendance were: Ned Daniels, Nick Shepard, Todd Mulvey, Aaron Loomis, Nate Gulden (and via teleconference: Brooks Boyd, Manny Johnson, Brenda Shopodock). Introductions were made. Chairman Daniels congratulated the Town Board on their new positions. Jason called the Town meeting to order at 1:10 PM.

James Crawford stated the importance of ATV trails and connectedness. A discussion took place regarding existing trails and the gaps within the trail system that make travelling between communities difficult. The tribe will be sending a letter to all surrounding entities to form an ATV committee.

Lynne informed the attendees that Randy Kramer had completed the work on most of the issues regarding road issues brought to the Town's attention by FCP Highway Department. Nick Shepard also brought up two additional issues including a section of Young's Lane/Potawatomi Trail in addition to a turtle crossing signs.

Lakeview St – County Park Rd – Keith Siding Rd – Schalk Ln— Hemlock Lake Rd - W Shore Ln (Hemlock) -  
– Kimberly Ln – Lake Lucerne Dr – Potawatomi Trail - Fire Tower Rd – West Shore Dr (Lucerne) – Young's  
Ln- Jaeger Road, Billy Daniels Lane-W Shore Drive (Lucerne)

Ryan will inspect the Northern part of the Township including: Wilson/Bessette Rd, McKeague Road, Gretzinger Ln – & Linneman Ln. and Railroad Ave.

Following the road inspection, the Board identified areas of need to include the following.

- Culvert-West Shore Drive (Lucerne)
- Culvert-W. Shore Lane (Hemlock) -Very Rough
- Culvert-Gretzinger Lane
- McKeague Road-Very Rough
- Keith Siding Road-Low lying area between previous paving projects & bad area from ATV trail though corners
- No Parking Signs-County Park Road
- E. Lakeview Street-Repave/Culvert (?)

- Shouldering
