Jefferson German Watershed Phosphorus Reduction Project Grant

Le Sueur SWCD is happy to announce that we have received a grant to work on phosphorus reduction projects in the Jefferson-German Watershed. The goal of the Jefferson German Phosphorus Reduction project is to improve water qualitv in the chain of lakes by strategi-

cally placing Best Managements Practices (BMPs) in targeted locations within the watershed.

Best Management Practices:

This grant will provide us with the funding to offer cost share to

landowners
looking to install water
and sediment control
basins, grade stabilization projects, shoreline stabilization projects, wetland restorations and cover crops.

Where does the money come from?

The \$387,100 Le Sueur SWCD was awarded comes from the Clean Water, Land and Legacy Amendment. The

Amendment, passed by voters in 2008, raises sales tax by 3/8's of 1% and helps fund "on-theground" projects throughout the state.

Staff Update: Jack Bushman - MN CREP, Walk-In Access

MN CREP:

Landowners looking for returns on marginal land have the option to enroll cropland into the Minnesota Conservation Reserve Enhancement Program (MN CREP). MN CREP is a permanent easement program that is funded through a state-federal partnership. Feel free to call or stop into the office to discuss eligibility. Enrollment is continuous and expected to continue for the next 3 years.



Walk In Access:

If you're a landowner with land in a high quality natural cover (CRP, RIM, Other Non—Cropland) and are interested in receiving between \$10 and \$13 per acre by allowing public hunting on your land, the Walk-In Access program might be right for you. Enrollment in WIA is open until April 27th, 2018. Please contact the office for more info.



Staff Update: Nik Kadel - Ditches and Buffers

Ditch Work:

In 2017, we completed over 20 ditch projects and inspected around 30 ditch systems. Some of the ditch projects this year were: general sediment removal, sloughing repair, replacing/resetting cul-

verts to the correct grade, repairing crossings, replacing or repairing county tile and handling the beaver problems in the ditch systems.

Redetermination:

Le Sueur County is in the process of having

the redetermination of benefits done on county ditches 19, 28, 42, 52, 54, 69 and Le Sueur-Rice judicial ditches: 18, 63, and 5. The redetermination of benefits is a process in which the county hires viewers to investigate the properties around the

ditch system to determine which properties are getting benefits from it and assess property according to their findings.

Buffer Law:

In 2015 Governor Dayton signed into law the Buffer Initiative. The law requires established vegetative buffers on public waters/streams by November 1st 2017 and along county ditches by November 1st 2018. The SWCD elected jurisdiction to do the buffer enforcement in the county. We have Buffer Cost-share for the establishment of buffers. Please contact the office for more info.

Drainage Records Grant:

Le Sueur County was awarded a Drainage Modernization records grant to update the historical records to today's standards.



Staff Update: Sue Prchal- WRAPS Interviews, Tree Sales

WRAPS Interviews:

Le Sueur County SWCD received a Watershed Restoration and Protection Strategies (WRAPS) grant. Part of the grant will be used to interview landowners within the Lower Minnesota Watershed about water quality, erosion concerns and conservation practices. The information collected will be used to formulate a planning effort to help solve issues in these designated areas. Look for me to be out and about asking for a brief 10 minutes of your time to get your opinion.

Tree Sales:

The SWCD yearly tree sales program is ending soon. If you are still interested in ordering bare root conifers or hardwood trees and shrubs, give our office a call or visit our website.

Trees will be arriving around the 2nd week in April.



Manager's Minute: Mike Schultz-2014 Flood Relief, WRAPS, 1W1P, Conservation Corps

2014 Flood Relief Projects:

The SWCD has been up to some great things. We have been focused on completing our 2014 flood projects, which are the result of a grant the county was awarded after that years severe flooding. The funds where used to replace existing structures that were damaged from the event. We expect to wrap up the grant this spring. Please remember that anytime after a major natural weather event if your property receives any soil or water damage, take time to document it. We never know if the county will be declared a disaster site and receive funding to address the damage.

Lower Minnesota Watershed WRAPS:

On November 30th, 2017 the SWCD partnered with the county to hold a Watershed Restoration and Protection Strategy (WRAPS) meeting at the Next Chapter Winery in New Prague. The meeting was spent discussing county, state and federal programs that help address resource concerns in the Le Sueur and Rice County parts of the Lower Minnesota Watershed, and getting feedback from stakeholders on how we should focus our efforts. The SWCD is also conducting in person interviews with landowners in the watershed. Please stop by the office to request an interview. We will be interviewing landowners until April 2018.

<u>Cannon River One Watershed One Plan</u> (1W1P):

The Cannon River 1W1P process is over 50% completed. Le Sueur SWCD and the county are working with major Cannon River watershed partners in an effort to create one comprehensive plan for the watershed. A draft of the plan should be made available come spring 2018. If you

Staff Update: Joe Jirik- Cover Crops, Construction

Cover Crops:

Cover cropping is relatively new to Le Sueur County but the practice has been getting the attention of some farmers in the area who are starting to incorporate them into their farming operations. In 2017, over 700 acres of cover crops were seeded throughout the county. This was done with both financial support through incentive payments and with technical assistance provided by the Soil and Water Conservation District. In 2018, Le Sueur SWCD will also offer incentive programs throughout the county, with 2 targeted

areas; the Jefferson/German Watershed and the Sand Creek Watershed.

Construction:

In 2017, construction of conservation projects went well. The district completed 10 projects to reduce soil erosion. These projects included water and sediment control basins, along with terraces and waterways. There are many projects slated for construction in spring and fall of 2018. Please stop into the office if you have a soil erosion issue that you would like assistance with. Technical and cost-share assistance are available.
