| Rules                               | <p>Tentative Rules for play:</p> <ul style="list-style-type: none"> <li>• <b>Minimum of 8 players must be present or forfeit! Must have pitcher &amp; catcher!</b></li> <li>• <b>Run Rule:</b> 15 runs after 4 innings - Game over <b>or</b> 12 runs after 5 innings - Game over</li> <li>• <b>Strike Count:</b> 1 and 1-NO GRACE: If you walk a guy, it's a double and the girl can also walk or she can hit</li> <li>• <b>Home Run Limit:</b> Guys - 3 Home Runs Per team a game, then it's an OUT. Girls - 3 Home Runs Per team per game, then it's an OUT.</li> <li>• <b>Batting order:</b> (alternating order ex. Guy, girl, guy, girl.....)             <ul style="list-style-type: none"> <li>○ Extra Hitters: If teams use the EH, must EH a guy and a girl</li> <li>○ ASA BATS ONLY, MUST HAVE ASA STAMP OR DONT USE IT!</li> </ul> </li> <li>• <b>Field of play:</b> <ul style="list-style-type: none"> <li>○ Substitution Rule: Once you're out you're out</li> <li>○ Pinch Running: 1 runner per inning per guy/girl</li> <li>○ Plays at home plate. If you don't slide you MUST avoid all contact. Catcher cannot block home plate.
