



## North and South Campground Frequently Asked Questions FAQ



- Q) When will the camping application email be sent out?  
A) February 19<sup>th</sup> at approximately 8:00pm.
- Q) Do I need to be a MSRA member to camp?  
A) No, the campgrounds are open to all **registered** Back to the 50's participants.
- Q) Do I need to have a car registered for Back to the 50s to camp?  
A) Yes, applicants for campsites must be a **registered** "Back to the 50's" participant. You will need to show your registration letter, or BTT50s registration before entering the campground.
- Q) Who do I call if I have a question?  
A) Send all questions to the North or South email addresses. [north@backtothe50scamp.com](mailto:north@backtothe50scamp.com)

- Q) Do I have to send my information in every year?  
A) No, we will keep your information on file. If you have a change, such as you purchased a different camper or have changed your email address, please send a **separate** email to the North or South email addresses. [north@backtothe50scamp.com](mailto:north@backtothe50scamp.com)

- Q) What if I replace my camper with a different camper?  
A) Send a **separate** email to the correct email address, explaining that you have a new camping unit. Be sure to include the length (fully extended) and if it has slide outs. We can only make changes to the camping unit before we assign the camp spots.
- Q) What time will the gates open for the cars to enter the fairgrounds on Friday and Saturday morning?  
A) 6:20am.
- Q) Is there a size limit for campers?  
A) Yes, **North Campground** - the size limitation is **35'** (this is a State Fairgrounds imposed limit, vehicles approaching this length **will be measured**). **South Campground** - the campsites are larger and accommodate up to the Minnesota state limit of 45'.
- Q) Do all sites have power?  
A) No, most of the sites in the north have power (some tent sites do not have power). About 100 sites in the south have power.
- Q) Can I use a generator in the south?  
A) Yes, you can use a generator as long as it is quiet. Loud generators will not be allowed. Generators are **not allowed** or needed in the north.
- Q) If I had power last year in the south will I have power and the same site again?  
A) **No**, the sites are assigned by your application line number. That number is assigned to your application by the order the applications are returned to us. The first 100 returned application emails will have power.

Q) Can I park my car in my camp spot?

A) The campsite sizes are dictated by the fairgrounds, the campsites are assigned by the size of your camping unit. Therefore we **cannot guarantee** that your car will fit on any given site. We do have overflow parking for any car that will not fit in your site. Vehicle must line up with camper in the camp site

Small tent sites, depending on the arrangement, will not be allowed to park their cars with the exhaust pointing towards the tent, this is a safety issue.

Q) Can I bring my car trailer into the campgrounds?

A) Car trailers, cargo trailers and car dollies are **not** allowed in the campground. The Stella lot is setup to store trailers during the event

Q) I have a converted car trailer that I would like to use as a camper, is this allowed?

A) Car trailers converted to campers must be pre-approved by campground coordinator. Send an email to one of the email addresses [north@backtothe50scamp.com](mailto:north@backtothe50scamp.com)

Q) Can I park my camper on Friday or Saturday?

A) No, all camping units must be in the campgrounds on Thursday, there **will not** be any campers parked after 8:00 PM Thursday.

Q) What is the cost of camping?

A) The 2017 rate for camping is \$160, there are no refunds on camping.
