The Town Board is proposing road construction in 2024, so the road funds are up this year with most of the funds going to road construction. The assessor expenses are down this year since the revaluation is complete. Election wages and expenses are up this year due to 4 elections taking place in 2024. The other categories were fairly consistent to the prior year. The Reserve Funds were adjusted to conform to this budget.

Fire Equipment Reserve increase—\$30,000 to \$35,000

Road Reserve decrease—\$230,645 to \$130,542

Environmental Impact Reserve remains the same at \$44,645

Town Revaluation decrease—\$20,000 to \$0

Contingency/Unrestricted remains the same at \$25,092

American Rescue Plan Reserve remains the same at \$64,718

Total Reserves: \$415,100 decreased overall to \$299,997 and used for this budget.
