TITLE: CORONAVIRUS FISCAL RECOVERY FUNDS ALLOCATION

- WHEREAS, the Summit Lake Paiute Tribe is organized pursuant to Section 16 of Indian Reorganization Act of June 18, 1934 (48 Stat. 984) as amended, with the Articles of Association, and approved by the Secretary of the Interior on January 08, 1965, granting certain powers of the Summit Lake Paiute Council (see Article II, Section 1); and
- WHEREAS, the Summit Lake Paiute Council has the power and duty to represent the Summit Lake Paiute Tribe in negotiations with Federal Governments in matters to benefit the general welfare of its tribal membership; and
- **WHEREAS**, the Summit Lake Paiute Council is the duly constituted governing body within the boundaries of the Summit Lake Paiute reservation; and
- WHEREAS, the Council received input from tribal membership regarding the needs of the membership due to the negative impact from the pandemic; and
- WHEREAS, the Council considered the needs of the tribal members and families and reviewed the Treasury's Interim Final Rule regarding the Fiscal Recovery Funds (CSFRF/CLFRF) 2021; and
- WHEREAS, The Council hereby declares to issue cash assistance payments to all adult members in the amount of \$1,400.00 to each adult tribal members 18 years of age or older and an additional \$100.00 to all enrolled tribal minors under 18 years of age as of June 19th, 2021 to be distributed from the FY 2021 American Rescue Plan Act funding received from BIA through the CTGP Grant; and

NOW THEREFORE BE IT RESOLVED, that the Summit Lake Paiute Council hereby declares that funding in the amount of \$1,400.00 for enrolled adult (age 18+) and \$100.00 for enrolled minor (age under 18) Tribal Members as of June 19th, 2021 will be disbursed as a cash assistance payment.
